PURPOSE:

Senate Bill 606, passed by the 2016 Maryland General Assembly, establishes the Commission's purpose. It is to ensure the educational success of returning veterans, including their recruitment, successful transition into higher education and eventual graduation. The Commission accomplishes this by facilitating the sharing of best practices, and potential adjustment of policies and procedures, among the institutions of higher education and state agencies regarding academic programs and support services designed for returning veterans. Commissioners, representing institutions of higher education in the state, address the following issues: awareness of veteran reintegration challenges; communication and coordination of available veteran services at the institution, state and federal level – including financial aid and GI Bill support services, mental health services and the use of career and transition services, at the education institution, to facilitate post-educational employment.

 - Jeff asks how the move to Tungsten is going?
 - Frostburg: All invoices have been paid but The Frostburg Bookstore can not generate invoices. Tungsten does not have this option
 - Towson: Bookstore is used to 1905, printing out PO as bookstore is not able to process. Is there a lack of training? Counselors are not putting the
 - UB: Registrar felt veterans did not need the book stipend or housing voucher
 - Different schools have different processes for allowing for the Chapter 31
 - Payments however are being made quickly in most situations but not all.
 - Discussed what can we do as a committee to assist with these issues. Do we need training? Frostburg will reach out to Rich Brady for possible speaking at Frostburg

• Delayed payments? Any delayed Chapter 31 payments?

- UB has several from fall still pending.
- Frostburg has delays since fall of 2018.
- Case managers change with no notice so lose POC
- UMGC has some delays but not many
- Rich Brady is a good POC for Voc Rehab
- Josh Pittinger is also good POC here in Baltimore
- VR&E Nothing at this time
- Colmery Act:
 - Jeff gave background regarding the zip code issues
 - NASPA overview of Colmery Act they have to account for the last 3 semesters, so schools have to go back.
 - There will be no impact on the students but for accounting, schools have to report.
 - Frostburg: Reached out regarding and got a response to not do anything yet.
 Enter new students as new and assign the correct code. All back dating; hold off for further instruction. Guidance was to wait.
 - Question raised How does this impact students that graduated?
 - MHEC has received different guidance. Pending official notice from the VA.
 Hoping for stages as everyone importing at once could crash the system.

• Benefits in general:

 UMGC (KH) How many students per SCO should be the recommended? Recommendation is 200 for every 1. 14k-16k veteran students. UMGC is currently about 1500-1800/SCO. Towson is 1 SCO per 650. The recommendation is created so that there are more than 1. Most SCOs, certification is not their only job.

- MHEC (TGM): Training Requirement: Existing or brand new SCO have different training requirements. New SCOs will NOT be issued a log in until they have completed training. Make sure you have a transition plan. Training takes about 5 hours – National conferences by the VA can fulfill some of this but only if hosted by VA reps.
- Frostburg (DD): If they can't pay the bill, they can opt for a payment plan. School has a deferment form, charged \$45 for Veterans. Send copy of delayed payment letter as if they are 100%, the school cannot charge anything. MHEC will send a reminder. Recommend making
 - Section 103 For 31 and 33 cannot charge for delayed VA payments can charge for delayed owed by student if less than 100%.

MDVA UPDATE (DN): Denise gave a handout of all Veteran related legislation on the table.

- Commissions that are staffed cannot "lobby" on a piece of legislation. She will determine if we are able to even have a combined voice. State level apparently not, and federal with caution. You can testify as a private citizen or member of another group but not this group.
 - Can we come back as a group with a general statement?
- Frostburg (DD): Has the billing office sent an impact request? For this school it's about 500,000 because they are unlimited yellow ribbon
- UMGC (KH): Impact Chapter 33 and Chapter 35 800-850k. Last year we were 4 million plus in YR.
- Keith talks about PA 111 instate tuition for all students using Post 9/11 even after they benefits are exhausted.
- UB (JL): Take it back to your school. Talk about impact to your institution. If passed, let's talk about what we can do?
- MDVA (DN): Who we are and what we do

 - Pursue a meeting with a legislator for the fall.

 - g. Bowie (Jerry)
 - i. Brought in only freshman all other only online.
 - ii. Resource office open since October and he has seen no one since opened.
 - iii. Veterans Day will be a team's Veterans day
 - h. AACC (Kat) fully remote. Currently 100% online
 - i. Will keep student services fully remote through spring.
 - ii. Maybe Stage 3 in spring with students at 50% capacity.
 - iii. Have about 550 veterans students and Kat is the only advisor for veterans.
 - iv. Program Manager position is still available. Student advising virtually.
 - v. Veterans appreciation month! They utilize the booking app for meetings. They also use virtual advising rooms. They use VA work study students are set up to help with Veterans Virtual Rooms
 - i. MICUAA Jennifer Frank took Matt Powers place.
 - i. 8 campuses exclusively online. Some have small members online if needed. 5 campuses that are at hybrid.
 - ii. Most campuses are finalizing plans for spring. Many campuses ending semester with Thanksgiving
 - j. McDaniel: (Betsy) truncated sessions

- i. estimate most leave at end of Nov. Spring pushed back one week and remove spring break and end of term remains the same.
- ii. A lot of classes are offered online with some hybrid. There are some going every day. Successful with keeping things as safe as possible.
- iii. Veterans Day will not have much recognition for the actual day but keep in close contact with their veteran students.
- iv. Change terms instead of 4 classes for the term, created 7 shorter terms which did impact students using VA benefits to understand how the process worked so as to not use their housing allowance.
 - 1. Spring they are moving back to the 15 week term. A challenge to the students that are not great online learners.
- k. Frostburg: (Danielle) SVA has done well with keeping safe
 - i. Danielle set up computers in all offices that could offer spacing and 14 areas that are COVID compliant in the veterans' lounge.
 - Veterans Day There will be multiple outside events hanging wreaths and 1000 flags ordered to help. They will send food to veterans' center but won't attend.
 SVA is doing a letter writing campaign to send to the VA homes.
 - iii. Created a mask making event veterans have made over 1400 masks and donated them all over the state! Making them for competitive schools and different services.
 - iv. Have started with the Toys for Tots campaign
 - v. single occupancy on campus with no shared restrooms. A lot of outdoor programing such as movie nights.
 - vi. Spring SALUTE went off campus at Cumberland outdoor club and celebrating all grads
 - 1. Nov 17th is the ceremony and students go home right before Thanksgiving.
 - vii. A lot of limited student services and a lot of outbreak mostly with athletics. They shifted to the 7 week format as well and have been able to work through it.
 - viii. FSU is under contract union said no to pay cut and 12 people ended up losing their jobs within 90 days. Students are doing well but staffing is taking a toll.
- I. Montgomery College (Jason F.) Remote work limited individuals allowed on campus, essential personnel only. Certain trade has limited enrollment but required labs so allowing for smaller sized. No hard date at this time to re-open.

- n. MDVA (Denise) never shut down but some working remotely
 - i. Charlotte hall and cemeteries are open. Benefits specialists are taking appts.
 - ii. If students have issues with benefits specialists, call Denise and she will connect them.
 - iii. Veterans Day host ceremonies at 5 areas and provide infrastructure but committees take on event
 - 1. Nov 6th newsletter will state what events are taking place
 - iv. MD Trust Fund grants to veterans in need.

- Just received a large amount of money from the MD lottery 220,000 in the fund – they do not pay for educational expenses but evictions etc. There is an application process.
 - a. Where do we find this?

11. Recent 85/15 Rule Updates

- a. MHEC response
 - i. SAA has had a training before SCO received theirs.
 - ii. VA stance is that this has always been the law, just bolstering their compliance.
 - iii. Make sure with training that you understand supported vs unsupported students.
 - iv. Institutions with a waiver (may have to reapply) waives reporting by term but you should still be doing the tracking for compliance. They will be looking for 3 years if you are a waiver school, you should still be in compliance.
- b. Betsy had a question during the training. Not answered, but VA stated they would offer another training – How to identify supported and unsupported students as it's not clear. Definitions may not match with what is being reported. Cheat sheet is not very helpful.
- c. Everette: SAA side has concerns as well as they are being asked to review for compliance. Are they supposed to confirm calculations, it needs to be clear.
- d. VA has stated there will be an additional training for SAs as well that will hopefully clear up some of the clarity issues. Webinars do not allow for questions.
- e. Betsy: Can the SAA work with schools and the state to ensure that all is being done properly.
- 12. MHEC Updates Associate director of Veterans Affairs operating remotely
 - a. SAA best option is email or phone. Extended COVID for MHA online classes can be certified as hybrid if they were already set up to have it as a hybrid modality.
 - b. SAA business as usual. Trying to keep surveys virtual with a secure site upload sensitive information. They will set up with credentials. For survey itself, it would be handled very similar to a face to face set up with set date for review. If you do not have access to the docs needed, please let them know in advance so they can adjust.
 - c. Catalog submissions still working on getting the process to be electronic. Launch for spring terms? Some schools are still sending it in? Patience as they work through catalog submissions. If an update has not been addressed within 30 days, reach out to Everette directly or if a a student is waiting for an approved program, reach out directly.
