#### **PURPOSE:**

Senate Bill 606, passed by the 2016 Maryland General Assembly, establishes the Commission's purpose. It is to ensure the educational success of returning veterans, including their recruitment, successful transition into higher education and eventual graduation. The Commission accomplishes this by facilitating the sharing of best practices, and potential adjustment of policies and procedures, among the institutions of higher education and state agencies regarding academic programs and support services designed for returning veterans. Commissioners, representing institutions of higher education in the state, address the following issues: awareness of veteran reintegration challenges; communication and coordination of available veteran services at the institution, state and federal level – including financial aid and GI Bill support services, mental health services and the use of career and transition services, at the education institution, to facilitate post-educational employment.

    - iii. UMBC: Cliff states was created through a grant that has run out. Not required for staff/students but encouraged. Stickers received. Helps with understanding military with delays for payments etc. Really trying to get staff/faculty to understand. In lieu of training they have been working on an ambassador type program. Veteran gender not broken down just yet but most involvement is coming from female veterans. Programs with Amazon where they can help their veterans to receive food etc. if needed.     - iv. MC: Jason MC ELITE program in service training for all professors became part of multi-cultural requirements through HR. Veterans Day celebrations targeted non – veteran students – worked with production team. Originally as a panel but that didn't work – Jason will share the link. Female vets were about 24% of veteran population. So did some direct marketing – women's only veterans center.     - v. McDaniel: Betsy Atherton does not have GZ training mostly dependents very small population National Guard students having to drop because of call ups has anyone seen this?
    - vi. FSU Danielle Student veteran population about 212 veterans about 40% are females! Looking at some ideas for addressing this
    - vii. AACC: Kat more dependents and trending on female side so creating some female vet programs.
    - viii. TOWSON: Dena Allen-Few 211 veterans but close to 50/50 female numbers have increased. Changing culture of veteran's center to be more inclusive (No longer the Bro-Zone) Much more integrated with students that want to participate! 344 dependents using the benefit they don't have Green Zone training. COVID 85% off campus remote learning. Starting some in person classes 2nd week of Feb mostly labs and basic core classes. Mil/Vet center is closed on campus and all been forwarded to virtual mil/vet center Zoom it goes into the M-F 11 am 4 pm. https://www.towson.edu/veterans/

  - a. 85/15 Schools who are reporting they need to be following the guidance from Nov 2020. Supported/unsupported student information was retracted and reverted back to the old standard. The 35% waiver is still active. Plan to do a reset July 1<sup>st</sup>. Every institution in 35% waiver, will have to apply again for the waiver.
  - b. SAA Compliance surveys they ask for the 85/15 calculation. If you are a wavier school it does not exempt you from the calculation. Most questions please ask Everette to help get the information clarified. VA can be disconnected from how things are working and its helpful to have MHEC.
  - c. (DANIELLE PLEASE CLARIFY) Graduate students should be part of 85/15 reporting (Appendix B and how are students counted) VA student should be counted but should not be UG goes in VA column but Grad does not go in VA column
  - d. MHEC is a great resource!!
  - e. SAA Updates: Online application is live and seems to be working but welcome feedback
    - i. VA Oversite memo has strengthened requirements. List of supplemental documents such as proof of accreditation, financial soundness (for private), whenever a catalog submission is updated, the approving is for past programs as well as anything over 24 months needs new catalog submission.
    - ii. Annual submit documents and catalog
    - iii. Other than annual if its been awhile you need a full catalog review.
    - iv. Training on the 27<sup>th</sup> for VA training (day before schools)
    - v. Not big brother more of a coordinating board
    - vi. From: Shannon will MHEC ever be able to accept electronic/online catalogs. Need a static catalog to be able to address any issues that may apply to past information. It can be a PDF.

#### a. Updates of USM

 Tracey Jamison – Chancellor can make a system wide decision regarding vaccinations, but as of right this second, not required. Meeting with institutions daily but at this time, not required.

#### b. Updates of individual institutions

- UMGC New President Virtual commencement, veterans lounge which is incorporating WorkShop Wednesdays. Virtual advising - not back on site until first of the year and then phased plan.
- ii. Towson: Dena Allen-Few planning virtual orientations, 100% for fall, all staff back May 6<sup>th</sup>, Veterans are back and have been for about a month. Must be vaccinated. Virtual Office is still running. Graduation is week long in the outdoor football stadium allowing for Spring of 2020 through Spring 2021
- iii. SU Shannon hybrid for staff and SU held vaccination clinics for staff and students. Not mandatory but still have bi-weekly testing. Hoping to be back to somewhat normal. Football stadium graduation over a couple of days. Virtual orientation last two weeks of June and website created for each level, freshman, transfer etc
- iv. UMBC: Pam Holly Summer sessions online but fall 2021 primarily on campus (about 80%). Virtual orientation. Spring 2021 commencement will be virtual. Yesterday on HR website, recruiting for a new certifying official
- v. UMBC: Cliff Taylor, Grad Asst. Sending out cords for veteran graduation being mailed this week. Student veteran group RetrieveVets trying to run elections. Burned out and having difficulty getting people to participate. Cliff will be
- vi. Frostburg: Danielle Orientation is on-site for one day. Students will be on campus Saturdays in May/June. They have some hybrid classes running as well. Vet center has been open and work studies are still on site. It has been helpful. SALUTE and SVA are running. May 4<sup>th</sup> in Cumberland MD still having the event for SALUTE. Danielles team gets the stolls with patch, veterans cord and SALUTE cords. No stance on vaccinations of whether or not you have to have it. Testing twice a week. Union is supportive of vaccinations
- vii. PGCC Arthur Toole Still virtual return to campus May 24<sup>th</sup> 3 days a week Tue-Thur, potential on site in fall, graduation is virtual

- Veterans Affairs unit of MHEC works closely with SCO's for maintaining VA approval and helps with compliance surveys
- Wrapping up 4th quarter if you have not received one you should be ok with this year. October starts next year
- 85/15 Many questions and no answers. Plan is to train in Sept and roll out new requirements October 1st. Continue to follow current process until October then follow new guidance.
- MHEC gets the same training as the SCO's but usually only the day prior and cannot always respond to questions dealing with the VA
- Isakson and Roe 3 year requirement no longer a requirement. As of August 1 this should be utilized in regard to residency.
