I. Executive Summary

In accordance with the Annotated Code of Maryland, Public Safety Article, § 14-105 (a) and (d), the Governor's Emergency Management Advisory Council (GEMAC) is authorized to advise the Governor on all matters that relate to emergency management in Maryland. During the 2021 calendar year (CY21), the GEMAC, with a new Chair and a predominately new membership, built upon legacy work executed by the previous GEMAC memberships from 2017-2019.

Capitalizing upon institutional knowledge and member cohesiveness forged during 2019 and 2020, the GEMAC began the year with a strong start, utilizing its Legislative Affairs (LA) Subcommittee to diligently track and analyze proposed legislation up to *sine die* of the General Assembly 2021 Session. The result of GEMAC analysis and discussions was the production of memorandums to the Governor's Office of Legislative Affairs offering recommendations to support certain bills that were perceived by the GEMAC to be beneficial to the emergency management discipline and the citizens of Maryland.¹

The GEMAC also continued to investigate the efficacy of, and maintained advocacy for, the creation of a disaster assistance fund, managed by the State, to act as a financial "stop-gap" for Maryland local and State entities when disasters do not meet federal thresholds.

Building upon the GEMAC's analysis of and advocacy for emergency management legislation, the GEMAC continued to explore emerging threats and complex interdependencies of capabilities including: 911, cybersecurity, and continuity of operations. The GEMAC will continue to explore these topics with the intent of providing recommendations for legislative action or other actions that may be taken by the Governor to improve capability and reduce risk/threat exposure.

To end the year, the GEMAC ensured it remained abreast of its other statutorily mandated duties (i.e., management of the State Emergency Response Commission [SERC]); GEMAC members elected to receive a refresher of SERC's mission and scope

Supported by the Maryland Department of Emergency Management (MDEM), the GEMAC continues to provide value to the Maryland State Executive Branch, and the citizens of Maryland, by offering an independent, non-partisan, and holistic perspective for a wide array of emergency management topics. As always, the GEMAC strives to remain agile and relevant in the emergency management discipline and continues to actively serve the Governor, his office, and his designated homeland security/emergency management representatives in an advisory capacity.

II. Purpose, Mission, and Scope of Work

The GEMAC is authorized by statute and is charged with advising the Governor on all matters that relate to emergency management in Maryland.² In addition, Executive Order 01.01.1987.11 designates the GEMAC as Maryland's State Emergency Response Commission³ (SERC) in accordance with Title III of the Federal Superfund Amendments.

A primary focus of the State's overarching emergency management strategy is a whole-community approach, working not only with government stakeholders at the federal, state, and local levels, but also with non-governmental organizations, private sector partners, communities, and individuals throughout the emergency management system. In keeping with this whole-community approach, the GEMAC brings together subject matter experts from a wide range of disciplines, backgrounds, and geographic areas to discuss and develop specific recommendations for further study or investigation. As an independent advisory body, GEMAC members are given the opportunity to provide input and comment on the State's activities in moving Maryland forward and developing a comprehensive emergency management program.

III. Representation

By law, the GEMAC must include: fair and reasonable representation for local government; representation for organizations that represent volunteer firefighters and rescue squads; and representation from manufacturing, utilities, and communications industries. There is no size limit or minimum membership requirement for the GEMAC; individuals appointed to the GEMAC serve two year terms.

The Chairman of the GEMAC is Ronald Gill, Director of Emergency Management and Deputy Director of Homeland Security, Prince George's County. The current GEMAC is composed of 23 members, including the Chairman. Current GEMAC members began their terms in January 2020 with a two-year term commitment. See the membership roster in the table on page 5.

IV. Activities and Topics During 2021

February 22, 2021 Quarterly Meeting

The purpose of this meeting centered upon validating the work of the newly formed Legislative Affairs (LA) Subcommittee during the timespan of Dec 2020 – February 2021. During that time, the LA Subcommittee reviewed various bills of interest and assessed their impact on the emergency management discipline. During the meeting, the LA Subcommittee Chair, Jonathan Bratt, presented the GEMAC with the Subcommittee's recommendations framed within a "support, do not support, remain neutral, no comment" paradigm. Upon conclusion, the GEMAC endorsed the Subcommittee's recommendations and decided to voice support for two bills (SB658 & HB831). The GEMAC decided to provide no comment on any other bill. The GEMAC decided to draft and submit supporting memorandums for these bills to the Governor's Office. (Note: This memorandum was subsequently submitted on 26 February 2021.)

May 11, 2021 Quarterly Meeting

During this meeting, the GEMAC conducted a 2021 Maryland Legislative Session Hotwash. Jonathan Bratt, LA Subcommittee Chair, highlighted the results of the committee's work over the past six months, as follows:

- Conducted four intensive sessions to review bills germane to the emergency management discipline
- Provided specific feedback to the GEMAC on nine bills
- Drafted memorandums to the Governor's Office for support of bills
- Provided recommendations for future bills
- Provided continual updates of bill status and final disposition

Ben Yelin, JD, Program Director of Public Policy & External Affairs at the Center for Health and Homeland Security (CHHS) led the GEMAC through the remainder of the hotwash. Mr. Yelin highlighted relevant bills that passed, bills that failed, and potential ideas and priorities for 2022. GEMAC members had the opportunity to ask follow up questions that resulted in the following takeaways.

- Emergency management has always been an important component of government. COVID-19 demonstrated this at all levels of government.
- Maryland State legislators have been very supportive in pushing emergency management forward.
- A flexible State disaster fund is a useful mechanism for supporting jurisdictional damages that do not meet dollar thresholds for federal support. Continued legislative work is required to create and define funding mechanisms to support local jurisdictions and State entities during these non-federallysupported disasters.
 - Note: A memo was submitted in February 2021 by the GEMAC demonstrating the need for and potential solutions for establishing a disaster assistance fund managed by the State to be a financial "stop-gap" for Maryland local and State entities when disasters do not meet federal thresholds.

August 23, 2021 Quarterly Meeting

During this meeting the GEMAC explored the Maryland 911 Board and the Statewide 911 capability, in general. This topic was particularly relevant, and catalyzed by, the passage of legislation requiring the Maryland 911 Board to be relocated from the Department of Public Safety and Correctional Services to the Maryland Emergency Management Agency (MEMA) on October 1, 2021. Furthermore, this same legislation also elevated MEMA to a principal department within the Executive Branch of state government and, as such, renamed it to the Maryland Department of Emergency Management (MDEM). Scott Roper, Executive Director of the Maryland 911 Board, and Jack Markey, Director of Frederick County Division of Emergency Management; vice-chair of the Maryland 911 Board; and president of the Maryland Association of Counties' Emergency Managers Affiliate, were invited to speak on the topic.

The discussion was highlighted as follows:

- Overview of Maryland 911 Board Structure
- Overview of Maryland 911 Board Functions
- 911 Capability in Maryland (i.e., PSAP discussion, NextGen 911 discussion)
- Kari's Law
- Nexus between cybersecurity and 911 and required planning
- Q&A Session

Takeaways from the Q&A session may be characterized as follows:

- Local 911 centers have the capability to move operations seamlessly to alternate locations if required
- The 911 Board does not provide equipment for dispatch (e.g., computer dispatch or radios)
- Most local 911 Directors report to the county's emergency manager appointed under the Md. Code Ann., Public Safety Article, § 14-109(b)(1)
 - o In one jurisdiction, the 911 Director reports to the fire department
 - o In a few jurisdictions, 911 Directors report to the police department or sheriff's office
 - 911 Board core operations and functions will remain unaffected as the move occurs from DPSCS to MDEM

November 24, 2021 Quarterly Meeting

The GEMAC ended the year on a strong note discussing legislation, policy, and impacts on important topics. Ronnie Gill (Chairperson) and Jonathan Bratt (Legislative Affairs Subcommittee Chairperson) led much of the discussion which centered on the following topics and associated points:

- The GEMAC and MDEMA formed a partnership with the goal of collecting and generating legislative priorities for emergency management by interviewing "thought leaders" in the field.
- The high-level legislative priorities can be characterized as: Financial Reform, Professional Advancement, and Information Management.
- Within Financial Reform, the topic of the creation of a disaster relief fund and resiliency fund were revisited.

- Creation of economic triggers and the analysis required (e.g., SoVI or ALICE) to determine these triggers were discussed.
- Given the federal financial and legislative climate, GEMAC members expressed now may be a good time to put this idea forward to legislators.
- Emergency managers in Annapolis, Howard County, and Frederick County discussed the relevance of these funds and provided specific examples of how a fund like this could benefit Maryland's citizens.
- Within Professional Advancement, the topics discussed were: the designation of emergency managers as public safety professionals, licensure/certification for emergency managers, and the creation of the Chief Resiliency Officer.
 - One GEMAC member highlighted the well-researched benefit of having public safety professionals live within the community they serve. Tax benefits and pension benefits to emergency managers could help stem the ongoing and increasing retention and staffing issue within the field.
- Within the Information Management, the following topics were discussed: cybersecurity, after action reports, law enforcement information sharing with emergency managers, and supply chain information management.

The GEMAC framed this granular legislative analysis and actionable recommendations within the broader "What Keeps You Up at Night" analysis conducted in late 2019. This analysis consisted of questions to various professionals at various levels of government, NGOs, and private sector to inquire their thoughts on greatest threats to the emergency management discipline, Maryland, and the United States. Interestingly, the analyses broadly aligned especially on the issue of staffing and retention, training, funding, and cybersecurity.

Subsequent to this in-depth discussion, the following action items were developed:

- Establish a collaboration between GEMAC, MaCO, CHHS, MDEM, and MDEMA to:
 - Develop a one-pager, to be delivered to the Governor's Office, proposing the high-level framework of a disaster assistance fund.
 - Engage in conversation with the Governor's Office to gauge the interest in pursuing this course of action.
- Monitor legislation of interest for the upcoming 2022 General Assembly Legislative Session and provide recommendations to the GEMAC, as appropriate
- Continue to explore other courses of action on the topics discussed at near-future meetings

V. Learning from the Past, Planning for the Future

Overview

The impacts of COVID-19 placed extreme strain on the members of the GEMAC as most were involved in day-to-day response and recovery either in a local, State, NGO, or private capacity. COVID-19 and the transition of MEMA to a principle department within the Executive Branch of Maryland State government also placed a high-

degree of strain on the administrative support to the GEMAC. However, despite these challenges, the GEMAC was still able to succeed in meeting all of its goals and requirements.

The GEMAC intends to continue to mature its LA Subcommittee and refine timing and content of recommendations to the Governor's Office. The GEMAC will continue to expand and revisit cyber preparedness and security as well as alternative State-managed disaster assistance funding mechanisms. Additionally, the GEMAC will explore topics such as Continuity of Operations (COOP) and its nexus to 911, cybersecurity/cyber preparedness/cyber resilience, and all other hazards. Finally, the GEMAC was able to meet its goal in submitting at least two (2) separate recommendations to the Governor's Office and/or the Secretary of MDEM regarding topics relevant to the current implementation of emergency management within Maryland. The GEMAC will work to sustain this goal for the upcoming year.

Upcoming Meetings

The GEMAC meets on a quarterly basis, with additional meetings scheduled as needed. Anticipated quarterly meeting dates for 2022 are as follows:

- February 2022
- May 2022
- August 2022
- November 2022
