

PURPOSE:

Senate Bill 606, passed by the 2016 Maryland General Assembly, establishes the Commission's purpose. It is to ensure the educational success of returning veterans, including their recruitment, successful transition into higher education and eventual graduation. The Commission accomplishes this by facilitating the sharing of best practices, and potential adjustment of policies and procedures, among the institutions of higher education and state agencies regarding academic programs and support services designed for returning veterans. Commissioners, representing institutions of higher education in the state, address the following issues: awareness of veteran reintegration challenges; communication and coordination of available veteran services at the institution, state and federal level – including financial aid and GI Bill support services, mental health services and the use of career and transition services, at the education institution, to facilitate post-educational employment.

- To SCO's: Please ensure that when you complete the Catalog Review Form (CRF), every program in WEEMS must be addressed on that form! This includes ANY changes, name changes, deletions etc. Use 221998. If you do not have a copy email Wayne Holmes and he will get it to you. Why is this so important? An institution submitted without addressing some prior approvals, ELR withdrew the programs due to incomplete information on the CRF.
 - o Process: submit
 - Wayne Holmes then sends a draft to ensure all information is accurate (new process)
 Review draft and return as soon as possible. Extra step to help correct issues prior to them impacting the veteran student.

UPDATE: MHEC - Everette Jackson

- No updates on 85/15 VA cancelled updates and will hold at next office hours
 - o MHEC available to help with questions regarding reporting
- AVECO Regional SCO conference and group that serves mid-west East and central regions July 10-14 First in person conference in Crystal City. Cost varies if member or not. This conference does satisfy as a training opportunity
- SAA updates re-evaluating application process to streamline updates. Deeper reviews are beneficial but time consuming. In early summer will be sending out a new process training session. How to prepare a good catalog submission. Also, all SCO's aware that VA is backlogged and so is SAA. Reached out in Nov for catalog submissions and a lot in the queue. If you have a student that is pending authorization due to catalog let Everette know
- After approval letter has gone past 45 day processing time, reach out to MHEC for expedited approval, especially if impacting students
- VA is working on 60 day initiative to address backlog and are now working in teams for 85/15 in box,
- MD ELR position Hired but not yet placed so please just send to the MLR in box. She is former SCO from Coppin that will be assigned to MD.
 - May be late 22 early 23 before she is available for MD
- SAA are getting out of the compliance survey side. They will be handled via the VA and a 3rd party
- Isaacson and Roe Fiscal 23 Starting in October -
 - Will engage institutions regarding Risk Based Surveys instead of Compliance Surveys. Similar to SAA supervisory visits. Support for certification compliance surveys will come from the VA. They will be looking at indicators that may be identified as a potential risk. Information from DOE, if institution is on heightened cash monitoring, advertising, fluctuations in veteran enrollment or tuition and fees?
 - All are in a matrix. If you have had a risked base survey, this Fiscal 23 model is different.
 They are getting out of compliance work and trying to get more into addressing issues early on.

- MHEC still waiting on updates for new process but also know that any institution identified in that first year, MHEC is there to support.
- Question If 2022 2023 catalog is already done reach out as they may need to wait for the training
 - If school has not received a catalog review approval for last year should they wait to submit our new - If not submitted yet, need to submit.
 - o If its bi-annual can work with a bit differently but all must be within min of two years.
- Question VA shift from distance to in person learning Any training regarding how to do that shift from a SCO perspective?
 - If a student was in a resident course that was changed to online due to COVID, then VA would allow to receive payment despite shift to virtual.
 - VA deadline May 30th effective June 1st, you need to be in a hybrid course that is at least once in a hybrid.
 - Any info if VA may extend? Possible but nothing stated yet. Seems like the VA is trying to get back to some sort of F2F resident training
- Question: Date set for catalog training?
 - Late May or early June after graduations but before fall
- Question McDaniel College got a voicemail from consulting company that wants to set up a compliance survey and they have not returned calls.
 - Derrick has had a survey 3 months ago and still has not gotten results.
 - Melissa has had a survey but they were persistent
 - Everette will also follow up as to why they have not been persistent

- Howard CC 100% back on site business as usual
- UMGC Little change since going remote in March 2020
 - Largo 1 & 2 buildings preparing to sell or lease
 - Most work has gone remote
 - Sr Leaders and some staff at Adelphi Campus
 - Cancelled OCP April 26,27
 - Military and Veteran Entrepreneur and Appreciation Fair open to all veteran students/alumni. Guest Speakers Robin Fortner retired USMC E9 and Laurie Sales prior separated USMC
- Frostburg Only shut down half of one semester
 - Low enrollment and anxious to be on site
 - First in person SALUTE for two years at end of the month!!
- UMBC Open but masks are still required in classroom labs. Staff not required.
 - Mandatory vaccinations and hybrid version of the schedule.
 - o Dr. Ashby from Duke arriving in August. Hiring a 20 hrs a week veteran certifying official. Checking out websites! Towson website is really strong!
- UBALT Quick shift in mask requirement
 - o K95 Mask mandate on Monday and Tuesday no mandate Back in February.
 - Mostly hybrid "4 year community college" Tend to be more adult learners.

- o Fall of 2022 should be back to full operations for students
- o May 21st Military and Veteran Open House to all Military Connected.
 - Addressing mostly Community Colleges transfer Event
 - Special prize but can't tell what it is.
- Mt St Mary 2 campuses one never closed.
 - Frederick campus more evening adult online courses and went fully virtual but have hybrid options
- Stephanie UMES has someone working with veteran students
 - o 90% of veterans are not well aware of their VA benefits.
 - New recruitment strategy, going to high schools and help educate about things like dual enrollments.
 - Update Military Affiliated (MA) student website trying to transfer from admissions to registrar.
 - O Working on a resource guide for MA students.
 - o Engagement day coming up from 9am-115 pm. MD Dept of Labor.
 - Working on a radio show to work with MA students and allow them a chance to tell a story. Helping veterans in the community.
 - o 2nd academic year for Yellow Ribbon Program. About 100 students using GI Bill.
 - COVID status hybrid format, masks in common areas, vaccination required and 2x a
 week testing for unvaccinated. Limit of 15 for smaller event. Still working with social
 distancing.
- Towson Dario Fully back on site.
 - New VP of enrollment and they are located in Student Affairs so helps to have someone that will support working to improve processes. They work beyond just certifying - Mega Advisor
 - o Catch a Lift partnering with event Towson Town Festival April 30 May 1st
- Garrett County CC Back to normal no masks in person graduation.
 - o F2F, hybrid, Virtual remote, online Students have the option to attend in person or stream in real time.
 - O Asks how to handle certification if student is not required to be in person?
 - Masks in labs and classes but not offices. No vaccine mandate -
 - New president Anitha Cheek from Minnesota
 - Admissions Open House this Saturday 9-noon.
- UMCP Campus wide back in business masks optional in Feb. for offices
 - Commencement live and in person including more than current class.
 - Classrooms masks required. Trying to get full compliance of vaccinations.
 - ACRO Association of collegiate registrars recommend joining
- WAU Working on a game plan to work with military as far as support.
 - Working on a survey for all Mil Affiliated to find some areas of strengths and opportunities.
 - Hybrid model for courses. Goal is to get all back but not there yet.
 - Masks not required but vaccines are.
 - Working on creating a veterans center.
- CCBC masks are optional end of March

- o Commencement from 2020 2022
- VRRAP Veterans enrolling in short term programs.
- CCBC is applying for YR and a final push in the VRRAP program as it ends in Dec.
- Dept of transportation grant in CDL training all 18 positions filled to the end of the year.

 - Ages 30-60 who may not be using benefits.

 - Full time classes at the Mount Veterans are trained to be "Contract Specialists"
 - Takes a commitment but great opportunity. Challenging and rigorous.
 - 10 months 36 college level business credits,
 - VA assists with holistic health, sleep, mentors, professional dev, tutoring, personalized advising, students are paid and given housing.

- After 1st 10 months move to 2nd phase for contracting classes and they sign a contract that they will go where they are needed.

 - a. The educational institution must adopt policy to ensure that it does not impose any penalty, including:

- b. assessment of late fees
- c. denial of access to classes, libraries, or other institutional facilities,
- d. require the student using to borrow additional funds due to the inability to meet financial obligations to the institution as a result of delayed payments for educational assistance from VA.
- 3. Can the school require a student to use his or her federal financial aid for tuition and fees while it awaits a VA payment?
 - a. No. The law prohibits the school from requiring a student to use his or her federal financial aid, or other sources of payment for tuition and fees while it awaits VA payments within the 90-day period. However, schools are not prohibited from allowing a student to utilize his or her federal financial aid, or any sort of aid or loan for tuition/fees during the interim period if the student wishes to do so. What a school may not do is insist that the student utilize this aid, take out loans, or do anything else so that the tuition and fees are paid in advance of the VA benefit payment.

- Camp LeJeune Drinking water issue drinking water was contaminated at the time (1953-1987). Presumption is a way to establish service connection. A list has been created. This list is separate from the class action lawsuit. If a service member receives a settlement from the class action lawsuit, the VA will withhold funding if SM attempts to make a VA claim as well. 15 qualifying conditions for dependents as well as SM. Risk Based surveys

October 1 begins the year in regard for the Risk Based survey includes a small record review such as advertising, finance, enrollment info and student complaints. Recommend you have additional staff available such as marketing and finance. On site – there are 4 records for review and not given students' names in advance and 2 are non-vets.

GUEST SPEAKER: Tom Riley - Dept of Labor Veteran's Employment and Training Service (VETS, agency with Dept of Labor not VA)

- What can we do for veterans as they leave the service?
- Often what they offered are called "Best kept secrets" 5 major programs
 - Jobs for Veterans State Grant
 - American Job Centers MD DL helps veterans get priority of service. This is not
 just blue collar jobs. Also helps with resume building.
 - Transition Assistance Program Connections at all installations across the state.PGAJC wanted to get linked in closer with the installations in the area.
 - Veteran Homelessness Homeless veterans re-integration program. Goal to get them off the street and into a career field.
 - Veteran's Preference (VP) Applies to federal employment and federal hiring. Veterans do get a number of "points" that aid in the application process for government jobs. If you see someone that is not receiving fair treatment, reach out to DL VETS.
 - Hire Vets Medallion Program (HVMP) Employers who are known to support the veteran population. Employers can apply and lists are available for veteran review of military friendly employers. Nationwide list so a great tool for veterans to look for jobs - even out of area.
 - Uniform Services (USARA) Authority to investigate areas of discrimination investigates federal and non-federal employers
 - Connecting people to the right places and organizations.
 - SBA in connected with veterans programs






How large is your military-affiliated student population? 16 responses




Does your institution have a Veteran/Military-Affiliated Center or Lounge? 16 responses




Does your institution have a veteran/military-affiliated resource counselor/personnel?




is this person your SCO?
