Dear Mr. Deschenaux:

In accordance with language set forth in 2015 Joint Chairmen's Report (JCR), page 168, and Transportation Article, § 2-103.4(h)(2), the Maryland Department of Transportation (MDOT) and Department of Budget and Management (DBM) are to report quarterly on all Executive Pay Plan positions.

The JCR language specifically states:

*"The Department of Budget and Management and the Maryland Department of Transportation are required to submit to the Department of Legislative Services (DLS) Office of Policy Analysis:*

*(1) a report in Excel format listing the grade, salary, title, and incumbent of each position in the Executive Pay Plan (EPP) as of July 15, 2015, October 15, 2015, January 15, 2016, and April 15, 2016; and*

*(2) detail on any lump-sum increases given to employees paid on the EPP subsequent to the previous quarterly report.*

*Flat-rate employees on the EPP shall be included in these reports. Each position in the report shall be assigned a unique identifier that describes the program to which the position is assigned for budget purposes and corresponds to the manner of identification of positions within the budget data provided annually to the DLS Office of Policy Analysis."*

Transportation Article § 2-103.4(h)(2) specifically states:

*"(2) Subject to § 2-1246 of the State Government Article, the Secretary [of the Department of Transportation] shall submit to the Department of Legislative Services, on or before, July 15, October 15, January 15, and April 15 of each fiscal year:*

*(i) a list of the position, pay grade and step, title, name and pay rate of each employee who was included in the executive pay plan as of the last day of the preceding fiscal quarter; and*

*(ii) the details of any lump-sum increases given to employees in the executive pay plan during the preceding fiscal quarter;*

*(3) (i) the quarterly reports required under paragraph (2) of this subsection shall include each flat-rate employee position in the executive pay plan;*

*(ii) each flat-rate employee position included in the quarterly reports under subparagraph (i) of this paragraph shall be assigned a unique identifier that:*


*1. describes the program to which the position is assigned for budgetary purposes; and*

*2. corresponds to the position identification number used in the budget data provided annually by the Secretary to the Department of Legislative Services."*

The JCR further directs that DBM shall author these reports. Please note that the attached report contains positions in MDOT's Executive Pay Plan (Grade 9904-9911) and Head of Agency positions (Grade 9999). Since MDOT has a separate independent human resources system, the DBM does not maintain records of MDOT's positions. I believe, therefore, MDOT should report directly to you on the same quarterly basis as required in the JCR, but separate from the DBM.
