Dear President Miller and Speaker Busch:

Pursuant to Senate Bill 371, Chapter 55, Acts of 1991, attached is a report entitled *Drunk and Drugged Driving by Juveniles*. The legislation directs the Motor Vehicle Administration (MVA) to:

- "(1) Regularly compile and analyze statistics on drunk and drugged driving by juveniles and young adults;
- (2) Work with the Department of Juvenile Services, the Administrative Office of the Courts, the Maryland State Police, and other law enforcement agencies to monitor the effects of Chapter 254 of the Acts of 1988 and Chapters 438 and 551 of the Acts of 1989 (requiring the imposition of an alcohol restriction on the license of a driver under the age of 21), and Chapter 284 of the Acts of 1989 ("administrative per se" law) on juvenile and young adult offenders
- (3) Annually report, subject to § 2-1312 of the state government article, to the General Assembly regarding the information collected under paragraphs (1) and (2) of this section; and
- (4) Publicize recent legislative enactments concerning drunk and drugged driving by juveniles and young adults."

## Drunk and Drugged Driving by Juveniles (Senate Bill 371, Chapter 55, Acts of 1991)

This report is written in response to language contained in Senate Bill 371, Section 6, Chapter 55, Acts of 1991, which calls on the Motor Vehicle Administration (MVA) to:

- "(1) Regularly compile and analyze statistics on drunk and drugged driving by juveniles and young adults;
- (2) Work with the Department of Juvenile Services, the Administrative Office of the Courts, the Maryland State Police, and other law enforcement agencies to monitor the effects of Chapter 254 of the Acts of 1988 and Chapters 438 and 551 of the Acts of 1989 (requiring the imposition of an alcohol restriction on the license of a driver under the age of 21), and Chapter 284 of the Acts of 1989 ("administrative per se" law) on juvenile and young adult offenders
- (3) Annually report, subject to § 2-1312 of the state government article, to the General Assembly regarding the information collected under paragraphs (1) and (2) of this section; and
- (4) Publicize recent legislative enactments concerning drunk and drugged driving by juveniles and young adults."

The District Court provides the MVA with an annual summary of juveniles charged. The most recent information provided by the Court indicates that 2,184 drivers under 21 Statewide were charged in FY 2015. The following chart provides data on the number of drivers under 21 charged with TR § 21-902 for the past three fiscal years:

The Maryland Department of Transportation (MDOT) initiated new activities, while continuing to build upon on-going efforts, to strengthen public awareness on the hazards and consequences of drinking and driving. Activities undertaken by the MVA, often working in concert with several other State and local agencies and community groups, are outlined in the following chart:

| The Maryland Driver<br>Education Program                                       | All novice drivers complete a comprehensive driver education curriculum for all driver education schools. | The Rookie Driver<br>Safety Program  | The Rookie Driver Safety Program promotes a strong and ongoing parental role in driver education and calls on parents to discourage drinking and driving, or using drugs and driving. A Rookie Driver - Coach Driving Agreement is included in the New Driver & Coach Practice Guide (RD-06) which outlines rules and privileges for vehicle use and encourages parents to establish sanctions for alcohol or drug use and driving. | The MVA's Central Operations and Safety Programs Division (COSP) manages the Rookie Driver Safety Program and collects information on research and best practices on Maryland driver safety issues.   |
| The Maryland<br>Strategic Highway<br>Safety Plan (SHSP)                        | Impaired driving is a core emphasis area in Maryland's SHSP. The Impaired Driving Emphasis Area Team (EAT) is dedicated to working on issues and incorporating key strategies and countermeasures on impaired driving across the state. The SHSP also includes young drivers as a target group that is represented within the Impaired Driving Emphasis Area Team (EAT).  | The MVA's Maryland Highway Safety Office (MHSO) is responsible for leadership and coordination of the State's overall highway safety program. The MHSO supports many highway safety activities, administers a highway safety grant program in which federal traffic safety funds are provided to state agencies, local governments, and other organizations to implement statewide and local impaired and drugged driving programs. |

| The Regional Traffic Safety Program                     | On a regional level, numerous community and high school-based drinking and drugged driving program initiatives target underage drinking including: Driving simulators and outreach efforts funded by "Ford's Driving Skills for Life" and State Farm Insurance Company in Montgomery, Anne Arundel, Baltimore, Howard and other counties; Allegany College's "Student Outreach to High School Students"; Montgomery County's "Keeping It Safe on Underage Alcohol Use" (KIS); Carroll County's "Every 15 Minutes"; MADD's "Power of Parents"; Washington Regional Alcohol Program's "Alcohol Awareness for Students"; and Anne Arundel County's "The 5th Quarter". | "Branded D.U.I." an<br>innovative drunk<br>driving film | The film was co-produced by and aired on Maryland Public Television in 2006 and was distributed to every high school in Maryland. The film showcases 11 real-life teens caught drinking and driving and interviewed as they underwent the court process resulting from their drunk driving charges. It explores the consequences from the fatalities the teens caused, including their experiences in jail.
