Background

The Children's Environmental Health and Protection Advisory Council (CEHPAC) was established in 2000 pursuant to Chapter 585 of the Acts of 2000. CEHPAC advises the Governor and General Assembly on environmental issues that may pose a threat to children. Specifically, Health General Article §13–1506 requires CEHPAC to:

- (1) Review and comment on existing rules, regulations, and standards to ensure that the rules, regulations, and standards adequately protect the health of children from environmental hazards by taking into account the special vulnerability of children because of their developing physiology, and because their exposures, behaviors, and diets can differ greatly from those of adults;
- (2) (i) Review proposed regulations submitted to CEHPAC, and (ii) recommend to the promulgating unit measures that would avoid or minimize any negative impact that the proposed regulation may have on the health of children;
- (3) Comment on any proposed regulations that may be submitted by any other principal department of the Executive Branch during the public comment period if CEHPAC determines that the proposed regulation will have an adverse impact on children's health;
- (4) Gather and disseminate information to the public, including the research and medical communities, community-based organizations, schools, and State agencies, on how to reduce, treat, and eliminate children's exposures to environmental hazards to further the public's understanding of the environmental hazards that may potentially affect children;
- (5) Recommend uniform guidelines for State agencies to follow to help reduce and eliminate children's exposure to environmental hazards, especially in areas reasonably accessible to children;
- (6) Create and promote education programs, in partnership with health and environmental professionals, for parents, guardians, and caregivers of children that include information on (i) the potential health effects of environmental hazards; (ii) practical suggestions on how to reduce children's exposure to environmental hazards; and (iii) any other relevant information to assist parents, guardians, and caregivers in protecting children from environmental hazards;
- (7) Provide input to the General Assembly on legislation that may impact environmental hazards that affect the health of children; and
- (8) Report to the Governor and the General Assembly annually on the activities of CEHPAC.

<u>Mission</u>

CEHPAC seeks to identify environmental hazards that may affect children's health and recommend solutions to those hazards through interdisciplinary problem-solving and coalition building. CEHPAC's goals were developed in 2001 and are reaffirmed annually. They are to:

- Ensure that the rules, regulations, and standards of the State protect children from environmental hazards;
- Educate involved parties regarding the environmental hazards that impact children's health and the means to avoid those hazards; and
- Enable children in Maryland to grow up in a safe and healthy environment.

<u>Membership</u>

CEHPAC is composed of nineteen members, including those from the General Assembly, State agencies, private sector representatives, and parents with interest and expertise in the area of children's health and the environment (see Appendix A for current CEHPAC membership).

CEHPAC Activities

CEHPAC convened in public session seven times in 2023, six times virtually and once in person at the UM Laurel Medical Center in Laurel, MD.

During the 2023 legislative session, CEHPAC discussed the following legislation:

CEHPAC has been actively engaged in various initiatives. The Council expressed support for HB 9 – "Equity in Transportation Sector" in a letter to the Chair of the Environment and Transportation Committee, aiming to enhance equitable access to safe transit for the well-being of children. Additionally, CEHPAC highlighted its pivotal role to State agencies through a letter to MDH's Office of Governmental Affairs. The Council also endorsed proposed regulations for the Lead Poisoning Screening Program in a letter to MDH's Office of Regulation and Policy Coordination.

CEHPAC received regular reports from an Indoor Air Quality (IAQ) and Schools Workgroup (made up of a mixture of CEHPAC members and interested individuals), which spent considerable effort reviewing information concerning indoor air quality, particularly in light of school indoor air quality concerns and science developed during the COVID-19 pandemic response. This group also focused on integrated pest management in schools, using information provided by the Maryland Department of Agriculture. During the March 21, 2023, CEHPAC meeting, the Council moved the activity of the Workgroup back into the Council as a whole.

In 2023, CEHPAC engaged in topics related to children's environmental health, COVID-19, and school environments. Specifically, these topics included:

- Indoor air quality and ventilation in schools,
- Use of safer cleaning products in schools for COVID-19 cleaning procedures,
- Housing and health, and
- Asthma.

CEHPAC members continued to express interest in the work of the Department of Agriculture related to pesticides and integrated pest management in schools, including efforts by the Department of Agriculture to update its guidance documents and technical manuals related to integrated pest management in schools, which were originally produced in 1999, and revised in 2006. CEHPAC members have expressed interest in contributing to or reviewing the revised documents as a part of the revision process.

CEHPAC also heard regular updates regarding the State's progress addressing childhood asthma, climate change, and blood lead levels as it relates to children's health.

Future Priorities

CEHPAC continues to work on the topics described above, as well as a number of new priorities for the coming year. These include continuations of previous activities (pesticides and other environmental hazards in schools), responding to emerging concerns (built environment and synthetic turf), and addressing additional concerns identified by CEHPAC's members. CEHPAC is also making plans to revisit some of the issues and concerns identified in the 2008 CEHPAC report, "Maryland's Children and the Environment" with the intention of updating the document for publication.

CEHPAC is also focused on filling the two existing vacancies among its members.

Conclusion

The issue of children's environmental health continues to be a major concern, and CEHPAC's role is to provide education and advice regarding these issues to policymakers and the public in Maryland. CEHPAC will continue to review proposed regulations and legislation to protect Maryland's children from environmental health hazards. CEHPAC will also maintain its current efforts to educate its members and other interested parties on the growing body of knowledge related to children's environmental health.
