

Dear Faculty:

Thank you very much for agreeing to serve on the faculty of the Judicial Institute program *Maryland Legal History* which is scheduled for Wednesday, September 22, from 9:00 a.m. to 4:00 p.m

The Board of Directors recognizes that many personal sacrifices are made when carrying out this commitment and would like to share with you some materials that will help you prepare for your program.

A Judicial Institute video and an *Instructor's Guide* are enclosed for faculty who have not served recently as a Judicial Institute instructor or coordinator.

The video was developed for the purpose of providing instructors with information that will guide them through the planning process and enhance their effectiveness as a teacher. The *Instructor's Guide* contains material on adult learning principles, participatory exercises and addresses gender/racial issues. It replaces any previously issued edition that you may already have and has been updated to include pointers on how to prepare a power point presentation, plan a video production, and utilize the wireless responder system.

The wireless responder system enables participants to respond anonymously to instructor's questions with the use of individual keypads. It allows participants to answer yes/no, true/false, and multiple-choice test questions from a remote device. Responses are instantaneously recorded and converted into graphs and/or charts for the participants to view on a screen.

If you have an interest in reserving the responder system for your program, please contact our office directly. Judicial Institute courses are often taught on the same day; therefore, reservations for this equipment will be accepted on a first-come first-serve basis.

The Board of Directors has adopted a policy that all Judicial Institute instructors who will require technical assistance for their presentations meet with a media developer in person at the Judiciary Training Center 2 to 3 weeks in advance of their program. This will provide the instructors and media developers with the opportunity to conduct a practice presentation with the equipment and review any last minute concerns. Please contact Ellen DeChant at 410-946-4902 for your technical needs. She can assist you by setting up an appointment with a media developer or answering media related questions.

As an additional service to Judicial Institute faculty, references and/or articles related to your topic are enclosed. The material is provided as an additional resource that you may wish to use.

A copyright permission form is included in the *Instructor's Guide*. The Board of Directors encourages you to use the form whenever you seek to reproduce copyrighted material for distribution, and to limit your written course materials to information that is relevant and useful to judges.

The Board requests that your written materials be produced in an electronic format so that they may be made available to other judges on Intra-net, CourtNet. We also ask that you forward the names and addresses of course instructors who have been added to the faculty. We will furnish them, as needed, with copies of the enclosed training materials and advise them on how to obtain administrative support from this office. Should you recruit additional judge instructors, please advise them to contact their respective administrative judge and assignment office so that they may be notified of their expected absence on the day of the program.

We ask that all instructors review and return the enclosed permission form that grants a license to the Institute to use materials prepared for the Judicial Institute. A current roster of the persons who have enrolled in your program is also enclosed. In a few weeks, an updated class list of registrants will be provided as well as additional information regarding your program agenda, written materials, room set-up, and audio-visual equipment.
