1. Call to Order by the Chairman

The meeting was called to order by Chairman Robert C. Murphy at 3:45. Those attending were:

2. Minutes of the Previous Meeting

The minutes of the previous meeting were approved unanimously on a motion by President Dyal.

3. Records Retention and Disposal Schedules

Schedules adopted since the last meeting were approved unanimously on a motion by Treasurer Maurer.

4. Old Business

Dr. Papenfuse reported that the City Council of Annapolis had adopted critical area zoning for the area of College Creek proposed for the hotel. As a result, the hotel appears to be a dead issue. Dr. Dyal commented on the complexity of the issues involved, but agreed that it seemed unlikely that plans for the hotel would be revived.

Dr. Papenfuse noted that since the hotel will not be built it would be necessary to pursue landscaping along the Naval Yard fence. Mr. Walbeck said that the work is already scheduled, with bids for the job due for release in January with work beginning on or about March 1.

5. Bicentennial Office

Dr. Papenfuse stated that most matters relating to the Bicentennial Office would be deferred to the next meeting of the Commission. He reported that Treasurer Maurer had received an inquiry from a correspondent urging the state to issue a Maryland medal. Treasurer Maurer suggested that such a medal might be appropriate in connection with Maryland's celebration of the bicentennial of its ratification of the U.S. Constitution next April. Dr. Stiverson will investigate the possibility of producing such a medal and report to the next meeting of the Commission.

Treasurer Maurer will provide Dr. Stiverson with the information they have secured on medals.

Dr. Papenfuse announced that Comptroller Goldstein had agreed to chair the Founding Committee for the Ratification Ball next April 28. The ball is sponsored by Merrill-Lynch, with proceeds going to support Constitution-related projects in Maryland.

Dr. Papenfuse reported that Dr. Stiverson and ten other Maryland projects and individuals had been given awards by the Council for the Advancement of Citizenship. He noted that of the 76 awards the Council is making nationally, eleven went to Maryland, which is an indication of the quality of many of the Constitution bicentennial projects that have been undertaken in the state.

6. Publications

Dr. Papenfuse distributed copies of the new edition of the Maryland Manual. He commended Diane Frese and her staff for the fine job they had done and a motion was passed unanimously by the Commission thanking Diane and her staff accordingly. Dr. Papenfuse noted that we had experienced severe problems with the compositor on this edition, and that as a result the next edition will be composed completely in-house on a desk-top publishing system.

Treasurer Maurer suggested that an unsatisfactory vendor's report be filed against the compositor. Dr. Papenfuse assured her that the report would be filed once the final bills on this edition are paid.

Dr. Papenfuse distributed new editions of the Governor's Mansion pamphlet. In response to questions, he explained why the pamphlet uses the term "mansion" when describing the house, noting that historically it is as accurate as "Government House." Dr. Papenfuse noted that Chris Allan and Nancy Bramucci deserve special commendation for the fine job they did in writing and producing the pamphlet and a motion to that effect was passed unanimously by the Commission.

Recent and Forthcoming Activities

Discussion of the State flag collection was postponed until the next meeting.

Dr. Papenfuse noted that <u>Maryland</u>, <u>A History of Its People</u>, which Dr. Stiverson co-authored, had been given to Mrs. Gorbachev by Senator Mikulski. All agreed it was an appropriate gift.

Dr. Papenfuse reported that he had been invited to speak at ceremonies in Rochester, New York, honoring Congressman Frank Horton's 25 years of service in Congress. Dr. Papenfuse had served as an office assistant on Horton's staff when the Congressman first came to Washington.

Dr. Papenfuse said that he and Chris Allan have been consulted by several firms interested in bidding on the architectural contract for the new National Archives building, which is proposed for construction in Prince George's County. According to the State Ethics Commission, they can serve as consultants on such a project as long as it is not an exclusive contract with a single bidder. Once the bid is let, Dr. Papenfuse will report to the Commission if he and Mr. Allan are hired as consultants.

A discussion regarding the location of the new National Archives building followed, with interest expressed in having the facility located at the University of Maryland. Dr. Papenfuse explained that College Park is one of five sites in the state that were under consideration, and indicated that he would keep the Commission informed of any developments with regard to how and when the final decision would be made.

The discussion of State House exhibits was deferred to the next meeting.

Dr. Papenfuse announced that the General Assembly will hold a joint session on the evening of February 15 at which time the Maryland Ratification Stamp will be unveiled.

8. New Building and Administrative Matters

Dr. Papenfuse noted that due to the hard work of Eric Walbeck and the Department of General Services, most of the work remaining on the building has been completed or is in the works. He expressed the hope that by the next meeting nearly all pending items on the punch list will be either resolved or steps taken to correct any incomplete or unfinished items.

9. Budget Review

Dr. Papenfuse reported that thanks to the budget committee's work, the Archives budget for the next fiscal year appears in good shape. The Governor has approved three new

positions for the next fiscal year, and a fourth position may be included in the over-the-MARC request. The Governor also approved adding funds to support the Maryland Federalist in the agency's over-the-MARC request.

Dr. Papenfuse explained that this year's budget is very tight, due to the transfer of a position to the Archives from the Department of National Resources. No funds came with the position, with leaves the Archives with a \$30,000 salary deficit. The exact budget picture will not be clear until after the first of the year, but as was discussed at the last Commission meeting, it may be necessary to go to the Board of Public Works for funds to offset the cost of the new position. Funds are also needed for Constitution exhibits in the Silver Room in the State House, and Governor Schaefer has suggested that this item be brought before the Board of Public Works. Dr. Papenfuse said that he is trying to raise the funds necessary for the exhibits from private sources, but it is too early to judge how successful such efforts will be.

10. Other Business

Dr. Papenfuse noted that Linda Lapides had been injured in an accident in Baltimore, and the Commission expressed its concern for her well-being and its sincere hope of a prompt recovery.

Dr. Papenfuse discussed the recent death of Judge Martha Wyatt, who had worked for him in the late 1960s on the Annapolis project. Judge Murphy commented on the great loss the judiciary had suffered by the death of Judge Wyatt, and mentioned that he would attend her memorial service at St. John's on Friday.

Phil Schneider is retiring as head of Records Management, and the Commission adopted a resolution, introduced by Comptroller Goldstein, expressing its appreciation for Mr. Schneider's service during the years that Records Management was under the Hall of Records Commission, and wishing him well on the occasion of his retirement from state service. The Commission will present Mr. Schneider with a copy of the Hammond-Harwood House Atlas of Historical Maryland Maps, coauthored by Dr. Papenfuse, as a token of its appreciation.

Dr. Papenfuse explained that thanks to Dr. Muller and Sue Martin at Johns Hopkins University, the State Archives had been given the Evans microprint edition of books published on America prior to 1800. Comptroller Goldstein introduced a resolution of thanks to Dr. Muller, Sue Martin, and the Johns Hopkins University for the gift, which passed unanimously.

Dr. Papenfuse noted that Marion Warren has given his extensive collection of photographic negatives to the State Archives, and that based on this collection and the Merrick Collection, Mame Warren and Nancy Bramucci are preparing 24 photographic panels for the House of Delegates Building. Dr. Papenfuse showed a mock-up of one of the panels, and noted that there will be one for each county and Baltimore City.

11. The next meeting of the Hall of Records Commission will be a luncheon meeting following the State of the State Address on January 14. The Archives will run a van shuttle between the State House and the Archives for those Commission members who need a ride.

12. Adjournment

The meeting of the Hall of Records Commission was adjourned at 4:11.

The history of Maryland is a 332-page textbook for high school students, according to one of its authors. Gregory Stiverson, who is with the Maryland State Archives in Annapolis.
