#### **BICENTENNIAL CELEBRATED AT ANNUAL MEETING**

Baltimore's bicentennial of incorporation was celebrated in a gala program on October 22, 1997, at the Clarence M. Mitchell, Jr. Courthouse. The festivities began with the rededication of the Cecilius Calvert Monument outside the St. Paul Street entrance. Judge James F. Schneider, Mayor Kurt L. Schmoke and several clergymen spoke at the outdoor observance, which also featured patriotic music and a color guard in authentic 17th century costumes.

Cecilius Calvert was the second Lord Baltimore and the first Lord Proprietor of Maryland. Under his leadership, the colony enjoyed the first free exercise of religion in the English-speaking world.

Moving indoors to Ceremonial Courtroom 400, our Foundation and the Bar Association of Baltimore City jointly sponsored the 1997 Term of Court Ceremony, which also incorporated a special meeting of the Baltimore City Council. Chief Judge Robert I.H. Hammerman began the program by presenting antique maps and a print of Baltimore Harbor to Mayor Schmoke, City Council President Lawrence A. Bell, III, and the citizens of Baltimore. Foundation President Joseph K. Pokempner and Association President Pamila J. Brown each made brief remarks. Mayor Schmoke and Council President Bell introduced commemorative

resolutions, approved by the full City Council present in special session.

Foundation Secretary, Judge John Carroll Byrnes, presented *Histories of the Bench and Bar of Baltimore City*, which he cowrote and edited. Coincidentally, Robert B. Kershaw, who was Layout Editor of the book, received the Baltimore Courthouse and Law Museum Foundation Achievement Award, presented annually for dedicated service. Foundation President-Elect, Robert T. Gonzales, presented Mr. Kershaw with his award.

In a more solemn portion of the program, Administrative Judge Joseph H.H. Kaplan made a portrait presentation in honor of deceased Judge John R. Hargrove and a special resolution in memory of Saundra E. Banks. Judge Hargrove was the first African-American prosecutor in the U.S. Attorney's Office in Baltimore, and then the first such Deputy U.S. Attorney. His distinguished judicial career began in the former People's Court and he became the first administrative judge of the newly-formed District Court. In 1974 he became a circuit court judge and in 1984, a judge of the United States District Court for the District of Maryland, where he served until his death.

Ms. Banks began her career in the court system in 1978, when she was elected Clerk of the Court of Common Pleas, one of the six constituent courts of the Supreme Bench of Baltimore City, predecessor to the Circuit Court for Baltimore City. She was the first woman to be so honored. In 1982, she was elected as Clerk of the Circuit Court, in which position she remained until her untimely death

in 1997, at age 49.

When the Courtroom 400 proceedings concluded, those who attended and participated were invited to a wine and cheese reception in the Mitchell Courthouse's second floor Calvert Street lobby.

# RESTORED COURTROOMS AND NEW DOMESTIC RELATIONS FACILITIES HEAD RENOVATIONS

Both Baltimore Circuit Courthouses had extensive renovations and improvements during 1997, featuring restored courtrooms and new domestic relations facilities. The addition of six new judgeships in 1996 and 1997, as well as a one time \$2 million appropriation from the State Legislature, provided the impetus for the changes.

Courthouse East is the home of two new domestic relations masters hearing rooms. Their first floor location brings them close to the Medical Services' Division, which was completed in 1996. One of the hearing rooms was moved from room 540, which was then converted to a fully operational courtroom, with jury room, for Judge Gary Strausberg. Similarly, courtroom 339 was refurbished with a jury box and jury room for use as Judge Bonita Dancy's courtroom. The chambers of Chief Judge Robert Bell of the Court of Appeals, located on the sixth floor, were completely refurbished. Those three rooms have a greatly-enhanced appearance and more functional use of space.

The Clarence M. Mitchell, Jr. Courthouse continued to be renovated. Neoclassical masterpiece Courtroom 600 was restored with new HVAC systems and a jury room. Jury rooms for Courtrooms 406 and 451 were refurbished with new carpeting and painting. During the Fall, work began to convert room 434 from the Lawyers' Conference Room to a fully operational courtroom. The project also includes three new jury rooms on the fifth floor to accommodate courtrooms one floor below. The Lawyers' Conference Room will be relocated to the fifth floor, next to the Bench Conference Room, which will also be renovated.
