The object of this bill is to procure a divorce a Vinculo Matrimonii by the plaintiff, Lilla May Meekins from the defendant, Jacob Meekins.

The bill recites that the parties were married on the 5th day of August, 1921 and lived together until the 9th day of April. 1926. That ever since said marriage your Oratrix has behaved herself as a faithful, chaste and affectionate wife toward the said Jacob Meekins. That the said Jacob Meekins has on divers days and times since marriage committed the crime of adultery with divers, lewd and abandoned women, whose names are unknown to your Oratrix and said offense has not been condoned by your Oratrix. That your Oratrix has not lived or co-habited with said defendant since she discovered said adulteries. That there are no children born as result of said marriage. That your Oratrix is a citizen of the State of Maryland, having resided in Baltimore City for more than three years prior to the filing of this Bill but that the defendant is a non-resident of the State of Maryland and when last heard of was in Chester. Pennsylvania.
