By the Examiner:

Q State your name, residence and occupation?

A John McDowell, 2506 McCulloh Street, Baltimore, bellman.

Q Do you know the parties to this suit?

A Yes, sir, I am the plaintiff and my wife is the defendant.

By Mr. Davis:

Q When, where and by whom were you married?


