TO THE HONORABLE, THE JUDGE OF SAID COURT:

2. 4. That there are no minor children as result of said marriage.

5. That your Oratrix is a citizen of the State of Maryland having resided in Baltimore City for more than three years prior to the filing of this Bill of Complaint but that the defendant is a non resident of the State of Maryland and when last heard **of** was in Philadelphia, Pennsylvania. TO THE END, THEREFORE:

(a) That your Oratrix may be divorced A Vinculo Matrimonii from the said Elias Diggs.

(b) That she may resume her maiden name "FORD".

(c) That she may have such other and further relief as her case may require.

May it please your Honor to grant unto your Oratrix the Order of Publication directed against the said Elias Diggs, a non-resident of the State of Maryland, commanding and requiring him to be and appear in this Court on some day certain to be named therein to answer the premises and abide by and perform such decree or order as may be passed therein.


