The State of Maryland for the use of James Kelly by Davis and Evans, his attorneys, sues James F. Trcka, for that on or about the 12th day of August, 1926 the said James F. Trcka was wrongfully and negligently driving an automobile on Orleans Street, City of Baltimore; that Anna Kelly, deceased wife of the plaintiff was crossing Orleans St. at the intersection of Iron Alley; that when the said Anna Kelly, deceased had traversed three-fourths the width of Orleans St. at its intersection with Iron Alley, the defendant, James F. Trcka, did wrongfully and negligently drive his automobile so that it struck the said Anna Kelly, deceased thereby causing her death and as a result thereof the said plaintiff has been permanently deprived of the society, association and services of his wife, the said Anna Kelly, deceased and has been greatly damaged. That the said Anna Kelly deceased was guilty of no negligence contributing thereto but used due care and caution.

WHEREFORE the plaintiff claims \$50,000 damages.


