Wilhelmina Mooney, plaintiff by her attorneys, Davis and Evans, sues the Metropolitan Life Insurance Company, a body corporate.

1. For that the defendant is a corporation duly incorporated with authority to utter insurance upon lives in the state; that in consideration of the payment by one Leonard Mooney, late of Baltimore City, deceased, of a premium of about twenty-five cents and a like sum to be paid to the said Metropolitan Insurance Company by the said Leonard Mooney, deceased, weekly during his life, the defendant made its policy and insurance in writing agreeing to pay the beneficiary therein named the amount named as benefits payable on sufficient proof of death.

2. That on or about the 18th day of May, 1925 Leonard Mooney died. That his death was not caused by any of the causes exempted in said policy and that the said Leonard Mooney fulfilled all the conditions of said insurance on his part.

3. That the plaintiff, Wilhelmina Mooney, was beneficiary under said policy. That the plaintiff has made due proof of the death of said Leonard Mooney and her own right as beneficiary under said policy in accordance with the requirements of said policy. That the defendant refused and continues to refuse to pay the amount of claim though often requested to do so.

WHEREFORE the plaintiff claims \$520.00.
