ORDER OF PUBLICATION

IN THE CIRCUIT COURT OF BALTIMORE CITY ALMA WRIGHT VS. HARRY WRIGHT

The object of thus suit is to procure a divorce a Vinculo Matrimonii by the plaintiff from the defendant.

The bill recites that the parties were married on or about April I2, I9I9, in Charlotte, Virginia; that there were no children as issue of said marriage; that the plaintiff has been a resident of the City of Baltimore, State of Maryland for more than two years prior to the filing of this bill and that the defendant is a non-resident of the State of Maryland. That the plaintiff has been a faithful, chaste and affectionate wife; that the defendant, Harry Wright deserted and abandoned the plaintiff on ornabout the I5th day of June, I9I9 and that such abandonment is deliberate and final and without any expectation of reconciliation and has been for more than three years prior to the filing of this bill of complaint.

It is thereupon ordered by the Circuit Court of Baltimore City this // day of the I923 that the plaintiff by causing a copy of this order to be published in some daily newspaper in Baltimore City once a week for four successive weeks before the /day of 1923, giving notice to the said defendant of the object and substance of this bill and warning him to be and appear in person or by Solicitor on or before the day of May of which 1923 to show cause, if any he may have, why a decree ought not be passed as prayed.
