Dear Governor Ritchie:

Yours of July 19th. At the time of writing my letter of July 18th I did not know of the contents of the attached copy of letter of July 14th.

Mr. Walton feels this a definite committment that Garvan will give to St. John's College the entire sales price of the Mullan property that adjoins the post office, the cost of which was \$35,000.00, plus some accrued interest charges. You may recall that at the time this Mullan property was purchased by Garvan, it was for the purpose of putting the Hall of Records there. The negotiations with Garvan have turned out badly, and in order for the College to keep its promise to furnish the land, they offered a site on the campus. This was in the nature of a duress measure.

To minimize any loss to the College by reason of giving up a portion of its campus, a plan similar to the Woodward Library was thought advisable for the new building; this new building to balance the Woodward Library on the campus, and conform to its style of architecture.

President Gordon tells me that the Hall of Records Building is about the size of McDowell Hall and the plan shows this building facing the street, not the campus. Such a building in size and location would of course not balance Woodward Library, and would in a measure put all of the St. John's buildings in the back yard. I believe it would be a great mistake to alter the ancient aspect of the present front campus of St. John's College by locating upon it any type of building that was not in strict conformity, in style and size, to what is now there.

The appropriation for the Hall of Records of \$200,000.00 I understand was based upon old prices. Present day construction prices are materially less, and it occurred to me therefore that out of the \$200,000.00 appropriation, sufficient money could be gotten to buy the Mullan property, build the Hall of Records, and let the purchase price of the Mullan property come to St. John's College, in cash. The College badly needs the money and the site adjoining the post office would in every way be a handsome improvement to the City of Annapolis, and equally as successful and useful to the State.

Dear Governor Ritchie:

I am instructed to transmit to you the following resolution of the Board of Visitors and Governors of St. John's College, which, upon motion regularly made and seconded, was unanimously passed at the meeting of the Board held in Annapolis, Naryland, on September 23, 1931:

"RESOLVED: That the Chair appoint a Committee to draft resolutions embodying the views of the Board regarding the possible co-operation of the College in providing a site for said Memorial Record Hall. The Chair appointed the following gentlemen on this Committee: Messrs. Buck, Gordon, Melvin and Pearl; whereupon the Committee submitted the following resolution which was unanimously adopted:

"WHEREAS, The General Assembly of Maryland, at its session of 1931, appropriated the sum of \$200,000,for the erection and equipping of a Memorial Hall of Records wherein, among other things as provided by law, are to be placed, preserved and made available for reference and study, the historical papers, documents and records now owned and to be acquired by the State of Maryland, and

"WHEREAS, The acquiring of a suitable site for such building has been committed by said Act of Assembly to the Board of Public Works:

"THEREFORE BE IT RESCLVED: That the Board of Visitors and Governors of St. John's College takes great pleasure in offering to provide, without cost to the State of Maryland; a site for the Memorial Hall of Records, at such location on the front campus of St. John's College as may be selected by mutual agreement between the Board of Public Works and the Board of Visitors and Governors of the College.

"BE IT FURTHER RESOLVED: That the further details of the offer and of the conveyance be likewise left to mutual agreement of the two Boards above named.

"BE IT FURTHER RESOLVED: That the President of the College is hereby authorized to transmit a copy of this resolution to the Governor of Maryland and a copy to the Board of Public Works."

It will be a great pleasure to cooperate with the State in any possible way should the college property be used as the site of the Memorial Hall of Records.

Mr. Douglas H. Gordon, Baltimore Life Building, Baltimore, Maryland.

Dear Douglas :-

I have your favor of July 15th, relative to the Hall of Records. The last Legislature placed the construction of this building and the location of a site for it in the hands of the Board of Public Works, but the money is not available until August 1932 and the Board has not yet done anything on the subject. I have been told that the Mullen house will be donated to the State free of cost if it is decided to erect the building there. Personally, I am disposed to feel that somewhere on the State House Circle would be a preferable site, and the State Comptroller feels that way, also. I will be only too glad to discuss the matter with you, however, before anything at all is done.

I did not answer your letter sooner because I only received it yesterday on account of absence from Annapolis, and I was not here on either Thursday or Friday of this week. I will have to be in Baltimore on Tuesday of next week and am uncertain about the following Saturday.
