A separate invoice is also enclosed for the total amount due for the image file and the use fee.

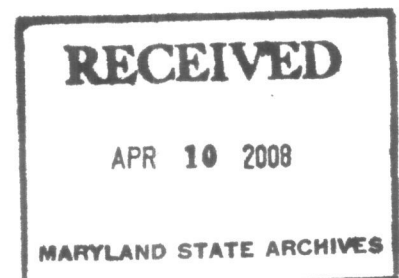
