THE LAST WILL AND TESTAMENT OF MARY A. MARSHALL.

I, Mary A. Marshall, of the City of Baltimore, in the State of Maryland, do make this my Last Will and Testament in manner following, that is to say:-

1. After the payment of all my just debts and funeral expenses, I give, devise and bequeath to my daughter, Sophia Stewart Marshall my pictures of "King Solomon's Temple", my Piano, Piano Stool and Music Cabinet and music; my son Joseph's picture and worked picture of Aunt Louisa; my China Closet; my silver spoons and all my silver articles.
2. I give and bequeath to my daughter, Annie Brady King, my China Fish Set, my Individual Tea Set, three Japanese Dishes, all now in the China Closet.
3. I give and bequesth to my daughter, Mary E. Young, the Bric a Brac Cabinet and all the contents of ornaments that are on it and Pedistel and Figures on it.
4. The balance of the furniture and contents of my house on the corner of W. Lanvale and Appleton Streets, I devise and will to remain in said house for the period of five years from the date of my death, provided my daughter, Sophia Stewart Marshall remains unmarried for that period of time, during which time or during her unmarried time, within the above named five years, she is to have the exclusive use, in her discretion, of said house and furniture, otherwise said furniture and contents are to be distributed and divided among all my children in such a way as she may agree upon.

6. All the rest and residue of my estate, real and personal of every kind and wheresoever situated, I give, devise and bequeath to "The Safe Deposit and Trust Company of Baltimore City", a body corporate, of Baltimore City, and its survivor, in trust for the use and benefit of my unmarried daughter, the said Sophia Stewart Marshall, for the period of five years from the date of my death, with power and authority to the said "Safe Deposit and Trust Company of Baltimore City" to manage the same, collect the rents and pay the net income thereof to my said unmarried daughter, Sophia Stewart Marshall for her support and maintenance, during her unmarried life. If she should marry within the period of said five years or until the said five years shall expire, the trust herein created shall expire and my estate shall be divided among all of my children as hereinafter provided for. In no event, however, shall this trust extend over the period of five years from my death. The said "Safe Deposit and Trust Company" shall have the power during this period to invest, re-invest, sell or dispose of any property belonging to my estate, which, in its judgment, may seem to it best for the interest of all my children.

7. At the expiration of the said five years from the date of my death, or the marriage of my said daughter, Sophia Stewart Marshall, the trust herein created shall expire, and my Executor hereinafter named, shall sell and dispose of all my remaining estate and distribute the proceeds thereof among my following children, John Milton, Clinton Walton, Mary E. Young, Annie Brady King and Sophia Stewart Marshall, equally after the amount of Two hundred

dollars each to Mildred C. Marshall and Leroy Marshall, children of my late son, Charles Archibald Marshall, shall be deducted and paid over to them.

8. I desire and request of my Executor hereinafter named, that a tomb similar in design to the one now erected over the grave of my late husband, Joseph M. Marshall, in Loudon Park Cemetery, be placed over my grave, as soon after my death as practicable, and for which the sum of Three hundred dollars (\$300.) above the State allowance shall be set aside.


9. I hereby direct and declare, if any person named in this my Last Will and Testament and to whom or for whose use I have made any devise or bequest, or any person claiming through, under or in trust for such person, shall dispute the validity of this my Last Will and Testament, or any of the dispositions herein, then all the dispositions herein in favor of the said person or persons, shall cease and be void to all intents and purposes whatever, and are hereby revoked accordingly.

10. I constitute and appoint the said "Safe Deposit and Trust Company of Baltimore City" to be the Executor of this my Last Will and Testament, hereby revoking all other Wills and Codicils by me heretofore made.


