

CERTIFICATE OF ELECTION

We, the Supervisors of Elections of Baltimore City and the Board of Canvassers for the City of Baltimore, do hereby state that we did duly meet at the usual place of holding, the Superior Court of Baltimore, on Thursday, November 8, 1934, being the Thursday next following the day of election and having each of us duly taken and subscribed before the Clerk of the Superior Court, the oath required by Law to be taken by us as said Board of Canvassers, did organize by electing Robert B. Knnis, Chairman and Lawrence F.
