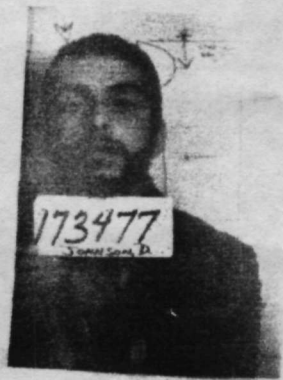

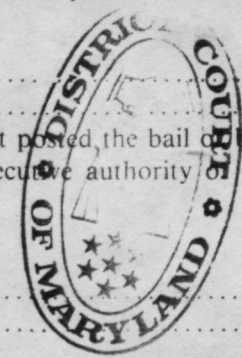



You know and I know a dead man doesn't need no medicine, Aloe and Myrrh which was used by two Doctors name Joseph and Nicodemus was medicine, and I need some medicine to help make this free National Constitution work for mental and spiritual slaves!

Your Honor you will be the God man in the court on June 15, 1987, I hope you will consider my past as not being totally abnormal, but prosperous also. Incarceration has served its purpose for me because I pleaded guilty to all I've ever done in this life, and I do have Educational skills at this time such as eighth grade certificate, G. E. D., Essex Community College, Business School, and I am a Labor Representative of the Annex Therapeutic Community here at Baltimore City Jail and in charge of the Annex Therapeutic Educational Program. I hope you will consider this upon sentencing
