### PLUM TRIAL JANUARY 25

Police Board Postpones It, Because
Of Counsel Change.

The date for the trial of Sergt. Frank J. Plum, of the Northeastern district, on the charges of accepting money for the protection of the bouse \$18 McCulloh street, kept by Marie Colder, was set yesterday by the Police Board for January 25. The board had decided to hear the charges against Sergeant Plum Thursday, but the date was changed because Mr. Luther E. Mackall, who was to defend Plum, will withdraw. Sergeant Plum will be defended by Mr. S. S. Field.

The postponement of the trial, it is believed, will enable Mr. Alonzo L. Miles, counsel for the Police Board, to prosecute the case. Had it taken place Thursday Mr. Miles would not have been able to act as prosecutor, because he leaves tonight for Buffalo to defend Captain of Detectives Pumphrey, who has been sued by a detective in that city for alleged services in the Black Hand plot against Mr. Joseph Di Giorgio, of this city.

Sergeant Plum will make an emphatic denial of the charges brought against him and will attempt to show that an effort was made to blackmail him.

"I'll prove my innocence," he said. "Wait until the trial comes up."

# FOR VACANCY ON THE LANNAN

Police Commissioners Discuss Question Of Lieutenant.

At a meeting of the Police Commissioners yesterday the question arose whether Sergt. Harry Knight, of the Central district, is eligible to take the examination to fill the vacancy of lieutenant on the police boat Lannan.

According to the regulations of the department only a round sergeant can take the examination for the lieutenancy in the marine department. However, there are none such who possess the necessary pilot's license, which Sergeant Knight holds. It is probable that some arrangement will be made by which Knight will take the examination. If this agreement is not reached Lieutenant League, who has been given shore duty, will be remanded to the marine department.
