 degrees East thirty perches North eighty two degrees East fifty six perches
 North twenty degrees East eighteen perches to two bounded Spanish oak
 saplings on the edge of a hill thence North eighty two degrees West fifty
 eight perches North forty eight degrees West forty five perches South forty
 nine degrees West twenty three perches to a bounded white oak standing
 on the edge of a hill thence South thirty seven degrees East twenty
 four perches South thirty five degrees West thirty two perches and
 thence by a straight line to the beginning containing and laid out
 for twenty six acres and one quarter more or less according to the
 certificate of survey thereof taken and returned into the land office
 bearing date the twenty ninth day of June seventeen hundred and eighty


