This Indenture made this tenth day of August in the year Eighteen hundred and sixteen between Israel Lee of Harford County (and) State of Maryland of the one part and William McBoy of the same County and State of the other part Witnesseth that the said Israel Lee for and in Consideration of the sum of one hundred dollars, lawful money of the United States to him in hand well and truly paid, the receipt whereof he the said Israel Lee doth hereby acknowledge, and from every part thereof doth hereby assign upon unto his charge (and) acquit the said William McBoy his executors and administrators hath granted bargained sold aliened enfeoffed released and confirmed and by these presents doth grant bargain sell alien enfeoff release and confirm unto him the said William McBoy his heirs and assigns all that tract or parcel of land being part of a tract of land called Snow Hill situate in Harford County aforesaid on the north side of Broad Creek, Beginning at a stone on a hill in or near the south line of the said tract called Snow Hill and running with said line north west by two degrees east thirty nine and seven tenths perches to a rock in a branch at the end of said line thence north twenty degrees east forty four perches to a stone south fifty six degrees east three perches to the second line of a tract of land called Meadow Land and with that line South twenty six and a quarter degrees west forty nine and seven tenths perches to the end of said line, thence with the third line of said land South fifty one and a half degrees West thirty perches to a stone, at the end of said line and with the fourth line of said tract South eighty six degrees and a half west thirty perches to a stone in said line, then North forty nine and half degrees east twenty one perches to a stone on a hill and thence with a straight line to the place of beginning, containing five acres one quarter and thirty perches together with all rights profits benefits (and) privileges thereunto belonging To Have and To Hold the same unto the said William McBoy his heirs and assigns forever. And the said Israel Lee for himself and his heirs the said land and premises and every part thereof against him (and) his heirs and against all and every person and persons whatsoever to the said William McBoy his heirs and assigns shall and will warrant and forever defend by these presents In testimony whereof he the said Israel Lee hath hereunto set his hand and affixed his seal the day and year above written.
