Notes

The breakdown by category may not be completely accurate, as it is not always clear which type or clemency was issued.

Generally, a commutation means the punishment was changed, often to whipping and/or payment of restitution or court costs. Occasionally people were bound out as apprentices or required to enlist in the US Army or Navy. The totals also include some instances where the Governor declined to issue a death warrant, as well as cases where a previously issued warrant was rescinded.

Banishment could be from the county, state, or country, and could be indefinite or for a period of years. In the case of slaves, banishment meant being sold out of state. The time allotted for leaving the state varied from 5 days to 75 days. Several banishments were later rescinded.

Death warrants totals may be slightly off due to multiple issuances of death warrants for the same people, usually because the condemned escaped before their execution was to take place. These re-issues were recorded in the overall list of black pardons but are not included in the totals.
