### CONSTITUTION

#### Article I.

This body shall be known as The Independent Colored Baptist Convention of the State of Maryland.

#### Article II.

The Officers shall be, President, First and Second Vice President. Secretary and treasurer; the general duties of whose offices shall be faithfully performed.

#### Article III.

The Object of this Convention shall be for the mutual intercourse with one another as colored Baptists in the State of Maryland, and throughout the United States of America by instituting and fostering such religious enterprises as may be established and carried on among us as a distinctive colored work, including our National Baptist Publishing Board, under the efficient management of Dr. Henry Allen Boyd, of Nashville, Tenn.

#### Article IV.

The primary duty of this Convention shall be the spread of Christianity in Maryland, and in such other fields as may, from time to time, be determined by the Board of Management.

#### Article V.

Only acceptable bodies and individuals shall hold membership in this Convention. Membership shall consist of churches, Sabbath schools, religious, and benevolent bodies and individuals.

Churches, Sabbath schools, Religious and Benevolent bodies may become members annually by the payment of five (\$5.00) dollars in advance, and individuals by the payment of one (\$1.00) dollar annually in advance.

A Church not recognized by a regular Council of Baptist Churches is not accepted.

#### Article VI.

The entire list of membership shall be read before the adjournment of each meeting, including new members, and if objection be made to receiving them, or to the continuance of any one of the bodies or individuals, by majority vote, the names of such bodies or

individuals shall be stricken from the list of membership. Notice shall be given at the session preceding the call of the list, that it shall be called at the next session.

#### Article VII.

It shall be the duty of the Recording Secretary to get out the minutes and distribute them to the churches of the Convention; he shall be held for their proper and faithful execution, and the Board of Management shall determine what shall be paid for the publishing of the same.

#### Article VIII.

All officers (After June, 1930, because first officers June, 1928 are elected to office for 2 years), shall be elected annually and shall hold their offices until their successors are elected.

#### Article IX.

The President shall preside at all meetings of the Convention, preserve order, state and put all questions and announce the vote of the body. He shall sign all orders on the treasurer and see that the objects of this Convention are faithfully executed. The Vice President shall perform the same in the absence, death, or resignation of the President.

#### Article X.

It shall be the duty of the Recording Secretary to keep a correct record of the proceedings of each annual meeting and a roll of the names of the Convention from its origin to the time being; noting deceased members with an asterisk and submitting the same at each meeting.

#### Article XI.

The Treasurer, shall for the faithful discharge of his duty, give such security as may be required by the Board. He shall receive and hold moneys, deeds, and bequeathments belonging to the Convention; pay all orders of the Board of Managers duly signed by the President of the Convention, and his books shall be opened for inspection by any member of the Board, and he shall make a quarterly report to the Board and an annual report to the Convention.

#### Article XII.

There shall be a Board of Manager's elected annually, which shall consist of seven judicious members, with full power to use all necessary means to secure the objects and interests of the Convention.

Four members shall constitute a quorum to transact business.

#### Article XIII.

The Board of Managers shall have power to appoint its own Chairman and Secretary of its own members; its time of meeting, to estab-

lish and superintend mission fields; appoint, instruct, and direct the missionaries of the Convention, and fix their salaries, and issue orders on the treasurer of the Convention, duly signed by the president of the Convention.

They shall by a two-thirds vote, for a sufficient reason, remove any of its members and fill any vacancies that may occur; and the Secretary of the Board shall conduct the correspondence of the Board and of the Convention, and the correspondence of the Board shall be the correspondence of the Convention, when the Convention is not holding a sitting.

#### Article XIV.

It shall be unconstitutional for this Convention to have any relationship to any, but bodies which have in view like principles as held by this body.

#### Article XV.

This Constitution may be altered or amended by a two-thirds vote, at annual meetings, provided that twelve month's notice be given.

#### FIRST DAY-Morning Session

June 6, 1928.

The first session of the Independent Colored Baptist Convention of the State of Maryland opened Wednesday morning, June 6th, 1928, with the Ebenezer Baptist Church, at 23rd Street and Guilford Avenue, Dr. J. W. Jones, Pastor. The meeting held its session Wednesday, Thursday and Friday, June 6th, 7th, and 8th, 1928. The devotional services were led by Rev. G. W. West, Bro. J. H. Williams and Deacon Joseph Quickly. Rev. West lined Hymn No. 375: "O for a closer walk with God." Deacon Quickly read for a Scripture lesson Matt. 7:1—29 and prayer was offered by Bro. J. H. Williams.

The president, Dr. J. H. Williams, announced that the session was opened for business and appointed the following committees:—

Dr. J. W. Jones was asked to come forward and deliver the welcome address to the Convention. This he did to the delight of all. Dr. Jones emphasized the fact that the "Heart of man is handled by God, only by Him. Doctors with all of their skill can do nothing with the heart, therefore, says God, Give your heart to me and I will give thee eternal life. When God has your heart he can then control you, and that too in the right direction. He then can accomplish what he wants through you." I welcome you to what we have because I want you to lay aside the white man's crutches, as did Dr. Harvey Johnson in his day, and rise up and walk of your own initiative, taking charge of your own people and your own affairs. Rev. Delmar Williams gave a very timely response to the welcome address,

pledging the honor of the Convention to deport themselves worthy of all that Ebenezer has in store.

The opening sermon was delivered by Rev. Samuel Cephas. The president, Dr. J. H. Williams, asked the Convention to sing, "Over there," after which he called for the opening sermon by Rev. Cephas. Rev. Cephas came forward and took for a text Psalm 1:1-3. He very effectively contrasted the Godly and the ungodly, saying.:

- I. "The Godly, what they do not do:"
- (1) They walk not in the counsel of the ungodly.
- (2) They stand not in the way of sinners.
- (3) And they sit not in the seats of the scornful.

Many wholesome and instructive thoughts were given. The following visitors were present and introduced: Revs. Doctors M. Pettus, Anderson, Lewistall and R. C. Williams.

### Reports of Committees

#### ON RESOLUTIONS

We, your Committee on Resolutions, beg leave to offer the following on intoxicating drinks:—

Resolved, That the manufacture, sale and use of intoxicating drinks

(a) Makes the drunkard a slave to an unnatural thirst.

(b) Intoxicating drinks give excitement and exhileration with unnatural and pleasing results for a while. What follows re-action? This excessive pleasure of drink is followed by a corresponding reaction that leaves its victim much worse than usual during the hour and days that follow the drunkard's exciting hours of pleasures.

(c) Total abstinence is our defense. Protect the individual from the formation of every bad and sinful habit; society from a public nuisance, federal constitution from the dishonor of its 18th amendment. That in the opinion of this Independent Colored Baptist Convention is what will happen. The manufacture and sale and use of such drinks are contrary to Baptist principles and the doctrine of Jesus Christ, our Head; that it is the curse to morals, injurious to the personal piety and a positive hindrance to the Gospel.

Therefore, persons manufacturing, selling or using it are thereby disqualified for membership in this (I. C. B. Con.) Convention.

### ON CHURCH AND MEMBERS' RELATIONS

Resolved, That we discountenance and refuse to fellowship knowingly church or organization that has not been recognized and set apart by a Baptist Council and found to be in harmony with Baptist Polity.

Resolved, That, we emphatically discountenance and condemn the practice of church members belonging to one Baptist church, but attend and support some other church, whereby they give to the world an inconsistent example of Christianity, which is not alone detrimental to personal piety, but is an awful and pernicious influence among the Baptists in general. Be it further

Resolved, That, we take no subsequent obligations in church or conventions that have for thier objectives the violation of obligations already taken in our respective churches and the Independent Colored Baptist Convention of the State of Maryland; for by so doing we grieve and drive away the Holy Spirit, the Comforter of our souls. (First Baptist principles).

The following salient points were given at the Convention:

May 8, 1928,—To the Independent Colored Baptist Convention of the State of Maryland:—

Emergency Points-Salient-

This Convention must defend itself against villyfying statements, such as the following:

"Making jobs for itself." "Some men are making offices for themselves," "for their children," for such statements may be applied to any one through conspiracy; to any Convention or Association for ulterior purposes.

If you would keep yourselves from jungles and destruction you must not allow such statements to be in your minds.

You have no right to form anything among yourselves, and that too for good reasons, if you are going to allow your enemies, or those, who don't like some of you, to put you against yourselves with such statements. These statements serve only to divide you if you do not put "your enemies" in your offices.

If you are coming together by complaining about some one of your Convention holding office, you had just as well quit now, for some of you must fill office, for there must be offices to be filled. Some of you must be presidents, secretaries and treasurers. If you are coming in with an evil eye against some one of your group, whom your enemy does not like and against whom they have some personal grievance, then you should not be in this Convention.

Misleading statements are being made about you by those, who cannot use you, and they will fill your mind with their thoughts, that you have men, who are seeking plums, because they are doing it. You should not make misleading statements about others, but you should correct misleading statements they make about you.

There is a spirit in Maryland to break up everything that it cannot control.

May 9, 1928,—To the Independent Colored Baptist Convention—Logic for intelligent men. They will not join anything, which did not ask their presence in its formative period. What about church lodges and societies? Many of us and perhaps most of them organized years before you were born. Poor logic. Maybe you were not in the forming of the State of Maryland, then your logic will not allow you to join the state. Pay no attention to these villifiers for they will wreck our organization.

### CONSTITUTION

#### OF THE

## WOMEN'S INDEPENDENT BAPTIST EDUCATIONAL CONVEN-

#### PREAMBLE

As the Women of all ages of the world have been active in forming society, moulding character, and shaping the destines of mankind, especially along educational lines, we thought it well as Colored Baptist Women of Maryland to begin to bestir ourselves in the interest of our race and denomination.

We therefore organize ourselves into a body to be known as the Women's Independent Baptist Educational Convention of Maryland.

#### CONSTITUTION

#### Article I.

The object shall be to look after and foster the educational interests of Colored Baptists and to form Educational Department to the Colored Baptist Convention of Maryland.

#### Article II.


The Officers shall be a president, vice president, 2nd vice present, s cretary, assistant secretary, corresponding secretary and treasurer. The common duties of such officers shall be theirs. They shall hold their office until their successors are elected.

#### Article III.

The General State Body shall consist of Auxiliary bodies which may become annual members by the payment of three (\$3.00) dollars annually in advance.

#### Article IV.

Persons may become members of all auxiliary body by paying into the treasury of said body as follows: Adults, fifty cents annually in advance and children twenty-five cents; and the funds in the treasuries of auxiliary bodies, shall be turned over to the treasury of the General Body, whenever called for, and the money in the general treasury shall be at the disposal of the Board of the body to which this body is auxiliary.



#### Asticle V.

Five persons may form an auxiliary body by meeting and naming the following officers: President, Vice President, Secretary, Assistant Secretary, and Treasurer.

#### Article VI.

The officers of the Convention shall constitute a Board of Managers, for the General Body, and shall have power to manage all the affairs of the Convention where it is not holding a sitting. The President and officers of the Convention shall be the officers of the Board.

#### Article VII.

Meetings of the Board may be held at the call of the President, or by the request of a majority of the officers, or at the call of the Chairman of the Board.

#### Article VIII.

The officers of this Convention shall be delegates to the annual meetings of the Independent Baptist Colored Convention of the State of Maryland by the virtue of their office.

#### Article IX.

The Convention shall hold its meetings annually and such other meetings as the Board of this body shall deem advisable.

#### Article X.

It shall not be lawful for this body nor its auxiliaries to use the money raised for any purposes other than provided by the Convention.

#### Article XI.

Auxiliary bodies shall set their own time for holding meetings.

#### Article XII.

The officers of the General Body shall by virtue of their office, be members of all auxiliary bodies.

#### Article XIII.

Auxiliary bodies shall report quarterly to the Board of this body, and the Board of this Body shall make a quarterly report to the Board of the State Convention.

#### Article XIV.

The Board may, for sufficient cause, remove any of its members, and fill all vacancies, whether caused by removal, resignation, or death.

#### Article XV.

This Constitution is to take the form and have the force of a charter from the Board of the Independent Colored Baptist Convention of the State of Maryland, and the Board may for sufficient cause revoke the same.

#### Article XVI.

Alterations or amendments, may be made to this Constitution and Charter, after having been submitted and receiving the endorsement of the Independent Colored Baptist Convention of the State of Maryland.





#### CONSTITUTION

#### Article I.

This body shall be known as the Independent Colored Baptist Convention of the State of Maryland.

#### Article II-

The Officers shall be President. First and Second Vice President. Secretary and Treasurer; the general duties of whose offices shall be faithfully performed.

#### Article!!!.

The object of this convention shall be for the mutual intercourses with one another as colored Baptists in the State of Maryland, and throughout the United States of America by insituting and fostering such religious enterprises as may be established and carried on among us as a distinctive colored work, including our National Baptist Publishing Board, under the efficient management of Dr. Henry Alten Boyd of Nashville, Tenn.

#### Article IV.

The primary duty of this Convention shall be the spread of Christianity in Maryland, and in such other fields as may, from time to time, be determined by the Board of Management.

#### Article V.

Only acceptable bodies and individuals shall hold membership in this Convention. Membership shall consist of churches, Sabbath schools, religious and benevolent bodies and individuals.

Churches, Sabbath schools Religious and Benevolent bodies may become members annually by the payment of five (\$5.00) dollars in advance, and individuals by the payment of one (\$1.00) annually in advance

A Chuch not recognized by a regular Council of Baptist Churches is not accepted.

#### Article VI.

The entire list of membership shall be read before adjournment of each meeting including new members, and if objection be made to receive them, or to the continuance of any one of the bodies or individuals, by majority vote, the names of such bodies or individuals shall be stricken from the list of membership. Notice shall be given at the session preceding the call of the list, that it shall be called at the next meeting.

#### Article VII.

It shall be the duty of the Recording Secretary to get out the minutes and distribute them to the churches of the Convention; he shall be held for their proper and faithful execution, and the Board of Management shall determine what shall be paid for the publishing of the same.

#### INDEPENDENT COLORED BAPTIST CONVENTION

#### Article VIII

All officers (After June 1930, because first officers, June 1928 are elected to office for 2 years), shall be elected annually and shall hold their offices until their successors are elected.

#### Article IX.

The President shall preside at all meetings of the Convention, preserve order, state and put all questions and announce the vote of the body. He shall sign all orders on the treasurer and see that the objects of this Convention are faithfully executed. The Vice President shall perform the same in the absence death, or resignation of the President.

#### Article X.

It shall be the duty of the Recording Secretary to keep a correct record of the proceedings of each annual meeting and a roll of the names of the Convention from its origin to the time being; noteing deceased members with an asterisk and submitting the same at each meeting.

#### Article XI.

The Treasurer, shall for the faithful discharge of his duty, give such security as may be required by the Board. He shall receive and hold moneys, deeds and bequeathments belonging to the Convention; pay all orders of the Board of Managers duly signed by the President of the Convention, and his books shall be opened for inspection by any member of the Board, and shall make a quarterly report to the Board and an annual report to the Convention.

#### Article XII.

There shall be a Board of Manager's elected annually, which shall consist of seven judicious members, with full power to use all necessary means to secure the objects and interests of the Convention.

Four members shall constitute a quorum to transact business.

#### Article XIII.

The Board of Managers shall have power to appoint its own Chairman and Secretary of its own members; its time of meeting, to establish and superintend mission fields; appoint, instruct, and direct the missionaries of the Convention, and its their salaries, and issue orders on the treasurer of the Convention, duly signed by the president of the Convention.

They shall by a two thirds vote, for a sufficient reason, remove any of its members and fill any vacancies that may occure; and the Secretary of the Board shall conduct the correspondence of the Board

and of the Convention, and the correspondence of the Board shall be the correspondence of the Convention, when the Convention is not holding a sitting.

#### Article XIV.

It shall be unconstitutional for this Convention to have any relationship to any, but bodies which have in view like principles as held by this body.

#### Article XV-

This Constitution may be altered or amended by a two-thirds vote, at annual meetings, provided that twelve month's notice be given.

#### PROCEEDINGS

#### WEDNESDAY, JUNE 5th, 1929.-MORNING SESSION

The Second Annual Session of the Independent Colored Baptist Convention of the Sate of Maryland, held with the Israel Baptist Church Rev. J. H. Williams, D.D., Pastor.

Dr. Williams asked Revs. W. D. Leighton, S. J.Winder and Deacon Morton to conduct the devotional exercises. Rev. Leighton lined Hymn No. 661, "That Awful Day Will Surely Come." Rev. Winder read Rom. 12: and Prayer was offered by Deacon Moore of Pleasant Zion Baptist Church. After the devotionals, Dr. G. W. West, Vice President, introduced Dr. J. H. Williams, who extended a hearty welcome to the Convention. The address of response by Dr. Hayward followed. - 4. In order to avoid any misunderstanding in proper authority, and contriduction of terms that the word Convention as applied to the Women Education and Missionary Societies shall be stricken out and the word Society inserted.
- 5. Junior Missionary Union. Twelve boys and twelve girls, ranging in ages from six to twelve years of age. One to act as chairlady and one assistant chairlady for the girls. One boy to act as chairman and one as vice chairman. One secretary and one assistant.

These junior workers will be permitted to pass special baskets through the audience asking those present to give at least one penny for missionary and Educational work, during the hymn before the sermon, or some other convenient period of each service.

The boys work one Sunday and the girls the next Sunday alternately, only a sufficient number to serve at anyone time. The respective heads of these groups of boys and girls will be furnished with twelve bands. Straps of ribbon at least two inches bearing these words.

7. That the Colored Baptist State Convention of Maryland shalf convene each year on Monday after the first Sunday of the Month of June continuing in session, five successive days, three session a day, morning, afternoon and evening. The first and fifth days will be reserved for the Convention proper. Second day, Sunday School and B. Y. P. U. Congress, third day Educational Convention, fourth day, Missionary Convention.

Monday afternoon, President's annual address.
Monday night, Introductory sermon.
Tuesday afternoon and evening, Congress Address.
Wednesday night, Missionary Sermon.
Thursday night, Educational Sermon.
Friday 4:30 P. M., Popular Address.
Friday night, Doctrinal Sermon. Finance Committee.

#### Report of Committee on Resolutions

In view of the fact that experience has taught us some few things, we make the following recommendations:

1. That Secretary of the Convention shall notify the several speak ers on the program so as to be able to know whether said speakers expect to fulfill their places on the program by May 1st; and in the event that need's warrant, that the President, Secretary and Treasurer will be empowered to provide substitutes to meet such needs to carry out the program.

2. That the Secretary of the convention will send letters to the churches of the convention, notifying them to get ready for the coming Convention, and to instruct them to send the names of their delegates to reach the Secretary not later than June 1st to enable the President to have his list of committee to appoint on the opening of the Convention.

3. That the Secretary of the convention shall compile the minutes in time to have them printed and back in his hand by May 25th, to make sure there will be no dissapointment in having the minutes for

the setting of each Convention.

4. Whereas in the venture to maneuver a giganic organization like the Colored Baptist State Convention, an organ through which to propagtante its interests and its ideals is indispensable, and where as said organ must be within the jurisdiction of the Convention, and where as: the owner of the E. P. Co., and publishers of the Christain Evangel, a monthly magazine has offered to turn over to the Convention, said corporation and said publication free of cost and free of debt, be it resolved finally that the Colored Baptist Convention of Maryland, do hereby accept the offer and become owner of a newspaper through which we may better foster our work in the City and State.

#### REPORT OF COMMITTEE ON THE PRESIDENT'S ADDRESS

We, your committee on the President's Annual Address, beg leave to submit the following, nothwithstanding the fact that the President chooses not to publish his entire address, in order to save money in the printing of the minutes; We, having familiarized ourselves with it, in its entirety, and having been led into the unstanding of its vast importance. We, therefore, recommend that the following synopsis of the President's address will be adopted and go on record to his credit.

sim in present day uses.

The fact that many people have more faith in hoo-doism, fetishism, and in the practice of familiar spirits is alarming and painful to every true hearted Christian. It is the job of the convention to help the world see that God is not found in these things, but to the contrary God is to be found only when the sincere heart is in fervent prayer, as Our Lord prayed in the lonely hills of Gallilee and in the solitary hour in the Garden of Gethsemane.

2. Let us liftup the standard of aducation not a part from, but as it relates to religion.

We must place a premium on trained ministry so that the preacher who isn't prepared will be inspired to prepare himself. God has commissioned preachers to make disciples of nations by teaching them to observe all things what—so—ever he had commanded, but the people do not appreciate the man that quietly but plainly explain the word of God unless he does it to suit their fancy or fits into their popular notions.

Third and last, lift up the standard of Religion.

Lift up the standard of religion by denouncing the custom of pulling members into the church without a demonstration of a regenerated heart and such evidence must be actuated upon an impulse of willingness.

Lift up the standard by placing value on a preacher's message, and not so much on the manner of delivery; real preaching is simply making plain the word of God unto the people, but most of our folk will not appreciate a message unless it is accompanied with excitement.

Education when rightly understood is a phase of religion and not something apart from it or oppose to it, because no man can be educated unless he has the proper reaccurence and respect for God. The people can do much on this point to demand a educated ministry so far as possible and support them so much so the preacher who is already in the ministry or inspired to enter it, finds himself unprepared, he will be moved to efforts to better preparation; because in an age of educated pew, an educated ministry is demanded. The truth of the matter is that God is not always found in storms,

earthquakes, thunder and lightning, but is often found in the still small vice.

Lift up the standard of religion by letting go the immoral preacher, by placing value on a consistent Christ—life, instead on emotionalism A preacher may live ever so good and rightly divide the word of God but if he will not preach to suit the populær notion of the people they will slave him out. He cannot even get a chance in the pulpit of the pastor who doesn't live a consistent Christian life. On the other hand, if a preacher drinks liquor, live in adultery and what not, just so he creates a lot of excitement, people support and honor him so—much—so until there is no incentive for a preacher to live decent.

Friends we are the blame for so much immorality in the church and ministry; we have allowed the harmon to trail in the dust we have allowed virtue to fall to the vanishing point. God is holding us accountable for it inso far as that portion of it that we control. What are we going to do about it? God isn't satisfied neither should

we be satisfied. Therefore let us raise the standard. God wills it, Humanity demands it.

Whereas, The Williams and Jones University, situated in Israel
Hall. Orleans and Bethel Streets, Baltimore, Md., is the only school
of its kind in the State owned and controlled by the denomination,
we recommend it as one of the best in the State to give our people
a good and higher education, and to cultivate in them the spirit of
independence, freedom of thought; to set up the proper standards
of manhood to best serve the purpose of the race. It offers inviting
opportunities to ministerial aspirants and the laity as well, and

Whereas, God has prospered the work of our school this year, which was answer to your prayers and contributions.

Therefore, be it resolved. (1) that we recommend to all persons under our influence, who are seeking to secure a higher education, the Williams and Jones University. (2) This institution brings us obligations, as well as opportunities—

Therefore, be it further recommended that each church constituting this body will organize Educational Auxiliaries, the said Auxiliaries to effiliate or join the W. E. C., which will meet in session with this Convention next year, and to report something quarterly at the quarterly meetings. all of which will help to operate the University.

(3) Be it further recommended that the appointment of teachers will be made only when needs demand, and that the operating expenses be kept within the bounds of the approximate income of the Convention. (4) In view of the fact that religious education is so much needed, and, realizing the importance of Bible Truths being properly understood and interpreted by those that teach children, we herby recommend that each church represented in this Convention will strive to secure the best prepared teachers in heart and head to teach our Sunday School lessons.

We finally recommend that the said churches will help to promote religious education and Williams and Jones University by sending some worthy Sunday School teacher. or boy or girl, which is inspired fr the ministerial or missionary work, to be tutored at said institution.
