## Bradley T. Johnson on the Situation.

The Frederick News publishes the following  
letter from Gen. Bradley T. Johnson on the  
situation. As Gen. Johnson is well known in  
this county, his views no doubt will be read  
with interest:

"I went to Cincinnati, as a Democrat, to  
meet other Democrats for consultation and to  
examine into the condition of affairs, so as to  
be able to form an opinion of the strength of  
the elements of the opposition, with whom we  
were probably to be allied. The material of  
the Convention did not impress me, as representing  
any great popular sentiment, and I did  
not feel that the assurance that it did,  
from any source whatever, was satisfying.

That the meeting was rather the gathering  
of personal or local discontents, that the  
action of the Convention does not satisfy me  
in having the elements of strength from the  
Convention itself. Whatever force the  
national acquire must be from the name, and
