It was stated some time since, under the New York head, said to have been taken from a Paris paper of June 6, "That the King of Prussia, and all the states of the German Empire had acknowledged the Emperor of the French; and were making out new letters of credence for their ambassadors at Paris." The following Law passed at a session of the general assembly of North Carolina, A. D. 1865.

An act to prevent the vicious practice of Duelling within this state.

Be it enacted by the general assembly of North Carolina, and it is hereby enacted by the authority of the same, That from & after the passing of this act, no person, sending, accepting, or being the bearer of a challenge for the purpose of fighting a duel, though no death ensues, shall ever after be eligible to any office of trust, honor or profit in the state, any pardon or reprieve notwithstanding; and shall be further liable to be indicted, and on conviction before any of the courts in this state, having cognizance thereof, shall forfeit and pay a sum not exceeding one hundred pounds to the use of the state.

And be it further enacted, That if any person fights a duel in consequence of a challenge sent or received, and either of the parties should be killed, then the survivor on conviction thereof, shall suffer death without benefit of clergy; and all their aiders or abettors shall be considered accessories before the fact, and likewise suffer death without the benefit of clergy.

This day (says the Boston Centinel of the 15th inst.) His Imperial Majesty, NAPOLEON, Emperor of the French, enters his 36th year.—He was born at Calvi, in Corsica, August 15, 1769. He is married, but has no issue.

The Emperor of the French has four brothers and four sisters living, and all married.—His eldest brother, M. Lucien Bonaparte, resides in Rome; his second brother, is His Imperial Highness Prince Joseph, Grand Elector; his third brother is His Imperial Highness Prince Louis, Constable of the Empire; his 4th brother is M. Jerome Bonaparte, now residing in the United States.—His sisters are, Madame Bacchachi, Madame Santa Croce, Madame Murat, and the Princess Borghese, (if we mistake not) formerly Madame Le

Clerc, and lately married to an Italian Prince, nephew to Pope Pius VII. The Emperor's mother, and uncle, Cardinal Fetsch, also reside at Rome. The latter is Minister of France to the holy See.

The contraband goods seized by them on this occasion, amount to 700,000 livres.

Mediterranean Passports. Notice is hereby given, that it has been deemed expedient to change the form of the Mediterranean Passport issued to vessels of the United States; that from the eighth day of July next, those of the new form will be issued at the custom houses to every vessel, for which application may be made on a compliance with the terms prescribed by law and surrendering the former passport of which she may be possessed, if any, in which latter case no fees will be required for the exchange; and that by an arrangement agreed upon by the Barbary powers, with whom we are at peace, either the old or the new form of passport will be sufficient to protect the vessels of the United States, from capture until the 1st of July 1865, after which the old form of passport will be unavailable and the new one alone in use.
