May 14. Last week three Frenchmen arrived here by land from Canada, with a packet from the governor there, to his honour the commander in chief of this province; and by all we can yet discover, it appears that they are come on a very sleeveless errand; and 'tis generally thought, they have something of more importance in view.

Wednesday last capt. Phillips sail'd for London, and 'tis said carried off about sixty thousand of the dollars lately released from their confinement in the treasury.

By the last letters from Halifax we are informed, that by a ship arrived there from London they had advice, that a regiment of soldiers, and 600 English settlers, with 1500 Germans would be sent over this summer, and that they would have a man of war and two sloops station'd there for their protection.

And from Annapolis Royal, that the French inhabiting those parts, had received orders from the governor of Canada, to leave their habitations, and come and settle there, which some of them had done, and others were preparing to follow them. [A good riddance of bad neighbours.]
