OBITUARY. Lewis H. Urban. The community of Towson and vicinity heard with the deepest sorrow of the death of Lewis II. Irban, which took place at his residence on Thursday evening at 6.45 o'clock from typhold fever after not quite two weeks illness. Mr. Urban was in the 38th year of his age.

He was a native of the town, and one of its bestknown and widely esteemed citizens. When a boy he entered the printing office of the Baltimore County Union, but after a year or more service discontinued on account of a belief that the necessary onfinement was prejudicial to his health. Upon the death of his mother Mr. Urban, though a young man, assumed charge of the restaurant, which he conducted to the day of his death. He was deotedly attached to the best interests of Towson and took an active interest in every project calcu

lated to advance its prosperity. He was a man of excellent taste as the neat condition of all his prop-He took a deep interest, also, in political affairs. and was foremost in the ranks of the party in all hat tended to Democratic success, and was a man Mr. Urban was an active member of St. Francis' Catholic Church, Towson, and was one of the very first to take steps for the establishment of a congre gation here, and labored assiduously in the erecion of the present church. A Question as to Tax Sales .- At the recent sale of property situated within the "Belt" district to the County Commissioners, and as the property is now in the limits of Baltimore city the question naturally arises what will the County Commissioners do with the property in case it is not re-deemed. In the absence of legislation on the subject the question becomes a complicated one, and it will take nice legal discernment to suggest a remedy in the premises. The present Collector of Taxes is authorized to proceed with the collection of taxes the same as under the county law, but as the county has no further interest in the property the city of Baltimore ought to be the party who should look to its rights in the premises. The city will be expected to pay the expenses of the new wards, and it is certainly their duty to aid the Tax Collector in gathering the taxes. Floods of Water from the Clouds.—The fall of water during Tuesday night, Wednesday and Wednesday night, was very heavy. On Wednesday morning about 70 clock the downpour was tremendous. Roads and fields were terribly washed, and in many instances in low lands the growing corn was washed out or inundated, and much of the crop will be destroyed.
