The case was tried once before in the Criminal what is known, in general parlance, as a "rounder." Christopher appears to bear a good reputation with the exception, as charged, of having taken up with a woman of questionable character named Lida Cole, on who e account Logue seemed to have a grudge against him, which culminated in the shoot-

grudge against him, which culminated in the shooting as above related.

Messrs. Joseph SP Heuisier, Edgar H. Gans, of Battimore, and Messrs. R. R. Boarman and John I. Yellott, of Towson, appeared as counsel for the defense, and Mr. John Grason assisted the State's Attorney, Mr. F. I. Duncan, in the prosecution.

The following jury was impanelled in the case—Benjamin W. Bowen, foreman; Melchoir F. Benson, John A. Cain, William J. Jenkins, Oliver Kidd, John E. Crout, Peter Kessler, John I. Anderson, Jeshua Armacost, from the regular panel, and John Smith, Eugene Burke and Wm. G. Rogers, talesmen.

Mr. Lewis M. Bacon, Court Clerk, read the indictment, and Mr. John Grason made the opening statement on the part of the prosecution, and Mr. Edgar H. Gans outlined the case on the part of the defense.

Martenet, Civil Engineer, was admitted as evidence in the case, and the counsel for the prosecution then suggested that the jury be allowed to visit the premises. The utility of the inspection was discussed by the counsel on both sides, and finally the Court decided that the jury might be allowed to inspect the premises, but no one but the Sheriff and his deputies was to be present and no explanation was to be made by any one, and any State witness. was to be made by any one, and any State witness who would put in an appearance on the scene would be judged in contempt of Court and would be treated accordingly.
