RE-ASSEMBLING OF CONGRESS.

No Congress of the United States ever assembled under the very peculiar circumstances which surrounded the second session of the 51st, which took place on Monday, 1st inst.— The general result of the first session, which assembled one year ago, was a blot among other Congresses when controlled by a Republican majority, since the unhappy days of 1861. Last December the legislative power of the House was rudely seized by Speaker Reed, who allowed such legislation as he choosed to be enacted, regardless of the rights of a large Democratic minority, nearly equal the majority of the Republicans. This arbitrary and revolutionary Speaker recognized in debate whomsoever he pleased. He was blind in his right eye as far as the Democratic members were concerned, but had two good eyes for his Republican associates. Under the whip and spur which he relentlessly used, the Republican nags came upon the track and galloped around at his bidding; and throughout a long session, one of the longest on record, ten clearly elected Democrats were driven from their seats to which their constituents had called them; an infamous Force bill, affecting the rights and liber ties of 60,000,000 of people, was enacted in oneminute speeches; an oppressive Tariff bill rapidly rushed through without debate largely increasing the already grievous burdens of the people, instead of lightening them; an additional pension list of \$33,000,000 added to the already enormous list of \$109,000,000, many thousands of which are known to be fraudulent; and stripping the treasury of \$130,000,-000 of surplus left in it by the economical administration of Grover Cleveland-besides enacting other oppressive, unnecessary and infamous legislation calculated to lower the dignity of the American name.

An indignant people looked upon these things with wonder and dismay, and in that condition of disgust determined to apply the corrective, and it was famously done on November 4th ultime. An arrogant Speaker and his cowardly tools were promptly rebuked. The stolen majority of 10 was wiped out and completely obliterated under a Democratic majority of 136 for the 52d Congress. It was the quickest and the best thing the people could do, and was a most complete and terrible castigation. Therefore, under such circumstances the assembling of the rump of the House became a matter of the deepest interest. As soon as it is cooked enough to eat, all who are present begin eating and never stop until so full they can eat no longer. When the meat is cleaned out of the pot, it is refilled, and as often as they feel like it they eat. Every neighbor or friend who calls in has a large dish of meat set before him or her, which is invariably eaten. Those who are the most gluttonous in their natures eat up their rations often a day or two before issue day, but they never go hungry. New York as Seen by a Marylander-Its Great Gateways and Rapid Transit-Wall Street and the Stock Exchange-Wall Street Banks and Bankers-How they Rob the U. S. Treasury.

NEW YORK, Dec. 2d, 1890. Editor JOURNAL: It is said that 325,000 people pass and repass the entrances of the Grand Central depot daily, As many cross and recross the ferries leading from Jersey, and a multitude continually come and go over the great Brooklyn bridge on foot, in all manner of vehicles and rapid traction cars. Taking the great park as a centre, within a radius of ten miles, which would include Brooklyn, Jersey City and the many villages and suburbs bordering the Hudson and East River, dwell over four millions of people, a population greater by four times than that of the entire State of Maryland, including Baltimore city, with its half million. (?) This great number are actively engaged toiling and striving in every occupation and industry-commorcial, manufacturing and trading. One may easily see why rapid transit for such a multitude engaged in active trade is not only a necessity, but a sine qua non. For this purpose four elevated railroads, two on each side of Broadway, traverse the city. CHESAPBAKE AND OHIO CANAL. An interesting communication from Hagorstown to the Baltimore Sun of the 3d inst. in reference to the future of the Chesapeake and Ohio Canal under the control of the bondhold.

"The question of the restoration of the Canal seems to be settled. After twenty-three years' struggling the bondholders of '44 have gotten control and possession of the company's franchise and its property, and are entitled to operate it under the upervision of the Circuit Court for Washington County and the Supreme Court of the District of Columbia, until all the debte of the Canal Company are paid; provided they operate it so as to show yearly progress toward paying its debts. If they do not pay off the expense of repairs, say \$250,000. in four years from May 1st, 1890, and do not thereafter each year reduce the debt, then the whole property is to be sold at public auction.

The B. and O. has substantially the control of the Canal. The question that is vexing the minds of the brokers and dealers in bonds is whether the s. and O. will operate the Canal so as to earn profits. competition with the B. and O. as a coal carrier. This altogether depends on which side the interest of the Baitimore and Ohio lies.
