- An Act for the Publication of all the Laws within this Province, and for the Recording the same in the Secretary's Office; as also Transmitting the Journals of the Council in Assembly, and of the House of Delegates, into the said Office, to the End that no Person may be ignorant of the Laws in this Province.* 91
- An Act for punishing the Offences of Adultery and Fornication.* 92
- An Act directing the Manner of suing out Attachments in this Province, and limiting the Extent of them.* 93
- An Act for the better Administration of Justice in Testamentary Affairs, granting Administrations, Recovery of Legacies, securing Filial Portions, and Distribution of Testamentary Estates.* 95
- An Act ascertaining what Damage shall be allowed upon protested Bills of Exchange.* 107
- An Act laying an Imposition on Negroes, and on several Sorts of Liquors imported; and also on Irish Servants, to prevent the importing too great a Number of Irish Papists into this Province.* 108
- An Act for the Punishment of Blasphemy, profane Swearing, Cursing, and Drunkenness.* 111
- An Act for rectifying the ill Practices of Attorneys of this Province, and ascertaining Fees to the Attorney General, Clerk of Indictments, Attorneys, and Practitioners of the Law, in the Courts of this Province, and for levying the same by way of Execution.* 115
