

On motion by Mr. Dorsey, the question was put, That the following be added after the words "dis-qualified voters."

"And whereas this house have determined that a legal voter cannot be coerced, and that an illegal voter alone can be coerced, to disclose for whom he voted; and as it does not appear by any proceedings to which said persons have been parties, that they are illegal voters; and as the 19th section of the bill of rights provides for the security of the citizen, that in all criminal prosecutions every man hath a right to be informed of the accusation against him, to have a copy of the indictment or charge in due time, if required; to prepare for his defence, to be allowed counsel, to be confronted with the witnesses against him, to have process for his witnesses, to examine witnesses for and against him, on oath, and to a speedy trial by an impartial jury, without whose unanimous consent he ought not be found guilty; and as those proceedings have not been had in relation to those persons, therefore, Ordered, by this house, That the said persons shall not be called to the bar, to be coerced to disclose for whom they voted."
