On motion by Mr. Teackle, Ordered, That the three persons on the western shore, and the two persons on the eastern shore, having the greatest number of ballots, be the committee clerks of this house.

The house proceeded to ballot for committee clerks; the ballots being deposited in the ballot box, the gentlemen named to strike, reported that Isaac Hines and William H. Emory, were elected for the eastern shore; that Alexander M'Ilhenny and Jeremiah M.
