Goldsborough, and Littleton Dennis, be the first original directors thereof; and in case of the resignation or death, the refusal to serve, or removal out of this state, of any of the directors aforementioned, the vacancy thereby occasioned shall be supplied by an appointment of the governor and council," to insert the following: "and the governor, and members of the executive council, for the time being, shall be the directors of the said board, and the governor shall be the president thereof."
