

empower the governor to call out the militia to suppress insurrections and quiet disturbances, made at a session of assembly begun and held at the city of Annapolis the third day of November, seventeen hundred and eighty-three, (l) be and is hereby continued, and shall be and remain in full force until the end of the next session of assembly; that all those parts of an act of assembly, entitled, An act concerning estates tail and the jurisdiction of the county courts, made at a session of assembly begun and held at the city of Annapolis on the fifteenth day of June, one thousand seven hundred and seventy-three, (m) which relates to the jurisdiction of county courts, be and they are hereby continued, and shall be and remain in full force until the end of the next session of assembly; that another act of assembly, entitled, An act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis on the twelfth day of June, seventeen hundred and eighty, (n) and an act of assembly, entitled, A supplement to the act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis the seventeenth day of October, seventeen hundred and eighty, (o) and the fourth section of an act of assembly, entitled, An additional supplement to the act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis the tenth day of May, seventeen hundred and eighty-one, (p) be and they are hereby continued, and shall be and remain in full force until the end of the next session of assembly; that another act of assembly, entitled, An act to continue an act, entitled, An act for the regulation of officers fees, and for other purposes, made at a session of assembly begun and held at the city of Annapolis the seventeenth day of October, seventeen hundred and eighty, (q) be and is hereby continued, and shall be and remain in full force for and during the term of three years, and until the end of the next session of assembly which shall happen thereafter.
