William Poe—Bond dated 14th November, 1842—as Agent of the Augusta Insurance and Banking Company—has accounted for the year 1844.

Edmund Dieder—Bond dated 1st March, 1843—as Agent of the General Mutual Insurance Company—has accounted to 1st January, 1846.

George H. Newman—Bond dated 27th December, 1842—as Agent of the Sun Mutual Insurance Company—has accounted for the year 1844.

George H. Newman—Bond dated 3rd March, 1843—as Agent of the Hartford Fire Insurance Company—has accounted for the year 1844.
