And be it enacted by the authority aforesaid, consent of the
 Com^{rs} herein nominated for each respective County, or the Major
 part of them are hereby imposed, sometime before the five and
 twentieth day of March One thousand six hundred eighty & four
 to meete together upon the respective Lands & Places in the act
 before mentioned, or at some other convenient place where there shall
 be, shall there, there, to be agreed with the Owners & all persons interested
 in the sd Lands, & buy & purchase of the Owners & persons interested in
 the sd Lands, One hundred acres of convenient Land in the discretion of
 the sd Com^{rs} least prejudicial to the Owners, & after purchase thereof
 shall cause the same to be surveyed, & after the survey so made, of the
 One hundred acres of Land shall cause the same to be marked, & laid
 out and divided into convenient streets, lanes & alleys, with open square
 places to be left or which may be erected Church or Chapel & Market
 house, or other public buildings, & the remaining pt. of the sd One hundred
 acres of Land is more as may be into One hundred small lots, more
 or less, on some posts & stakes towards the streets or lanes, to the number of
 100 (100) out of which lots the Owner of the sd Land shall have his
 first choice for one lot, & we pray shall purchase more than One
 lot during the space & terme of foure months after five & twentieth
 day of March One thousand six hundred eighty & four, & that the lots
 shall be purchased by the Inhabitants of the County, & in case the
 Inhabitants of the County shall not take up the sd Lots within the
 times of foure months as aforesaid, it shall be then for any person or
 whatsoever, to take up the sd Lot or Lots, paying the Owners proportion
 for the same, and if any person or persons shall willfully refuse to make
 of any such Land, herein before mentioned, or any person or persons, through non
 Com^{rs} or for any Memory, or other Injunct^{ns} or disability, whatsoever
 that
