Whereas a good & profitable Act was made at an Assembly held at y^e City of St.
 the twentieth day of October in y^e third year of th^e Kings Dominion in y^e year of o^r Lord
 1678 Entituled An Act for regulateing Ordinaries & limiting y^e numb^r of them in this
 province y^t notwithstanding y^e good ~~provid~~ provision thereby made against such exaction
 & exorbitant of late hath found y^e same soe farre from remedying y^e said abuse y^t many of the
 are grown more excessive & outrageous in their prices & to avoyd y^e penalty of y^e said
 Law, doe refuse to deliver when desired unto their said debtors under their hands the
 particulars of y^e Liquors & accomodations had & received of them fearing y^e same should
 discover their unjust charge against y^e said Act & often times when y^e said debtors a
 overtaken in drink fraudulently obtaine bills under their hands & seals for such
 debts unjustly charged where by their books are discharged w^{ch} otherwise in suing
 said account y^e said books in Court would discover their illegal exaction by w^{ch} means
 devised they often avoyd y^e penalty of y^e said Law & much damage y^e said debtors to
 prevent w^{ch} abuses for y^e futur^e. **Be it enacted** by y^e right hono^r. able y^e
