

4) And between the Lots 60: & 61: upon y^e West of y^e P^r Wood Street and
run straight to y^e utmost Extent of y^e Pond hundred Acres of Land, and
it is further Ord^d: that a Street or Strand of three perches broad be layd
out upon y^e P^r Cambridge Cooke side (Ork) beginning at y^e uppermost
bounds of y^e P^r Land on y^e said Cooke side and running down y^e P^r
Cooke on y^e severall Courses to y^e Lot N^o: 72: and also upon y^e back
of the Lots 76: & 77: which is accordingly staked and layd out
as afores^d

Ordered that y^e Remaining part of y^e P^r one hundred Acres of
Land (Viz) all that Land lying between y^e P^r Lot N^o: 100 on the
North West side of the P^r High Street to y^e utmost Extent of y^e P^r
Land be appropriated; to y^e following Use (That is to say) three Acres
there of upon parcell whereof y^e Parish Church of y^e Parish of Great
Stoptankes now stands and was formerly purchased by the Vestry
of y^e P^r Parish of y^e M^r: J^r: Kerke to y^e use of y^e P^r Parish according
to y^e P^r Purchase so by them made and that two Acres more
of y^e P^r Land formerly by Act of Assembly Confirmed unto y^e
County of Dorset and whereon y^e Court house of y^e County now
stands to y^e P^r County Use and their Assigns for ever according
to y^e intent and purpose of y^e P^r Act of Assembly, the Middle of
the front on y^e High Street of y^e P^r two Acres of Land is directly
Opposite to y^e Line that divid's y^e 18 & 19 Lots and all Land lying
upon y^e P^r High Street between y^e P^r Church Land and County Land
is by the P^r Comm^r: laid out and appropriated for y^e Use of a Market
place for the P^r Towne and that all the other Lands lying upon
the P^r High Street about y^e P^r Court house Lands as all these
Lands lying upon y^e back of the P^r Court house Lands Market
place & Church Lands and between the P^r Church Lands and Lot
N^o: 100 be and are by the P^r Commis^r: given and appropriated
to y^e P^r Town for erecting publick Buildings and other necessary
Uses as to y^e Inhabitants shall seem most and convenient;
Memorandum that y^e Church Lands have twenty four perches
breadth on y^e High Street and that y^e Market place have twelve
perches of breadth upon y^e P^r High Street that y^e Court house Lands
have sixteen perches breadth upon y^e P^r High Street and that y^e
Court house Land if run back in length to make it contain two Acres
& that y^e Church Land run back in length to make it contain three
Acres and that y^e Market place run parrell to both in length
with the Street of them two;
