An Act Revising and Continuing an Act of Assembly Intituled An Act for Relieving the Inhabitants of this Province from Some Grievances in the Prosecution of Suits at Law

Be it Enacted by the Right Honourable the Lord Proprietor by and with the Advice and Consent of his Lordship's Governour and the Upper and Lower houses of Assembly And by the Authority of the same that the Above mentioned Act Intituled An Act for relieving the Inhabitants of this Province from Some Grievances in the Prosecution of Suits at Law made at a Session of Assembly begun and hold at the City of Annapolis the Twentieth second Day of June Anno Domini One Thousand Seven hundred and fourteen be and is hereby revised and Continued in full Force from and after the end of this present Session of Assembly for and During the Term of three years And to the end of the next Session of Assembly that shall happen after the said three years

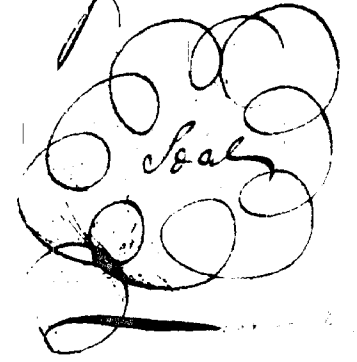

An Act for Repealing the Several Acts of Assembly now in Force in this Province that give Allowance for Killing Wolves Cows and Squirrels so far as they relate to the Killing Cows and Squirrels Only

Be it Enacted by the Right Honourable the Lord Proprietor by and with the Advice and Consent of his Lordship's Governour and the Upper and Lower houses of Assembly And the Authority of the same that such part of an Act of Assembly ^{made at a Session of Assembly} begun and hold at the City of Annapolis the Twentieth second Day of October Seventeen hundred and thirteen Intituled An Act for killing Wolves Cows and Squirrels - Also such part of another Act of Assembly made at a Session of Assembly begun and hold at the City of Annapolis the Seventh south Day of July Seventeen hundred and Sixteen Intituled a Supplementary Act to the Act for killing Wolves Cows and Squirrels that in any Manner relate to the Making Allowances for the Killing Cows and Squirrels Only be and is hereby Declared to be Repealed and made void any thing in the said former Acts Contained to the contrary therof notwithstanding -

Provided always that All and every Person or Persons who now have killed or at any time before the South Day of October in this present Year Seventeen hundred and Twenty three shall kill any Cows or Squirrels And upon Producing the Heads or Scals thereof to any Magistrate in Order to Obtain a Certificate thereof will before such Magistrate swear upon Oath or Affirmation (if a Quaker) or Otherwise make appear that such Cows or Squirrels were actually killed in the County wherein they pray Allowance at any time before the said South Day of October then it shall be lawfull for such Magistrate And he is hereby Injoynd to give a Certificate thereof Accordingly upon which the person or persons Obtaining such Certificate shall have Allowance for the same in the same Manner as if this Act had never been made
