

Secretary's Fees.

- For a *Recordari*, Seven Pounds of Tobacco.
- A *Subpœna ad Respondendum*, with three Names, Nine Pounds of Tobacco.
- Every Name more than three, Four Pounds of Tobacco.
- An Attachment of Contempt, Ten Pounds of Tobacco.
- A Proclamation of Rebellion, Sixty-seven Pounds of Tobacco.
- An Injunction, Thirty-two Pounds of Tobacco.
- An *Audita Querela*, Fifty-nine Pounds of Tobacco.
- A Writ of Enquiry of Damages, Twenty-two Pounds of Tobacco.
- A Writ of Covenant to pass a Fine, Nine Pounds of Tobacco.
- A Commission to take an Acknowledgment, Sixty-seven Pounds of Tobacco.
- A Writ of Assize, Eighteen Pounds of Tobacco.
- A Commission to fine Officers, upon a *Melius Inquirendum*, or *Monstraverunt*, Sixty-seven Pounds of Tobacco.
- A *Ne exeat Provinciam*, Sixty-seven Pounds of Tobacco.
- Drawing any Instrument that passeth the Seal, if it exceed One Side, computing Seven Words to a Line, and Fifteen Lines to a Side, and so *pro rato*, Nine Pounds of Tobacco.
- Recording the same, as before, Nine Pounds of Tobacco.
- Entering any other Matter upon Record, if it does not exceed Half a Side of a Leaf, Five Pounds of Tobacco. If the Matter entered upon Record be above Half a Side, computing as before, for every Side Nine Pounds of Tobacco.
- Copying the same with Recording, Nine Pounds of Tobacco.
- Any Warrant or License, against or to One Person only, not under the Seal, Nine Pounds of Tobacco.
- Any Warrant or License against or to more than One, not under the Seal, then for each, Nine Pounds of Tobacco.
- Any other Pass or Discharge, not under the Seal, Nine Pounds of Tobacco.
- Search of a Record, the First Year, Nothing. Search of a Record above One Year's Standing, for every Year within the First Five Years, *per Annum*, Three Pounds of Tobacco. And for every Year above Five, *per Annum*, One Pound of Tobacco.
- Filing every Bill in Chancery, Twenty-two Pounds of Tobacco.
- Every Court the same shall continue, Twenty-two Pounds of Tobacco.
- Filing every Answer, Twenty Pounds of Tobacco.
- Every Oath to the same, Seven Pounds of Tobacco.
- Writing a Commission and Bond, and Recording it, for every Sheriff's Office, One Hundred and Thirty-five Pounds of Tobacco.
- A Writ of *Posse Comitatus*, Sixty-seven Pounds of Tobacco.
- A Writ of Discharge, if any, Sixty-seven Pounds of Tobacco.
- Writing and Recording a Commission, and *Dedimus Potestatem*, for the County Court, One Hundred Eighty-six Pounds of Tobacco.
- Every Writ, and Return, Sixteen Pounds of Tobacco.
- Every *Subpœna*, and Return, twenty-two Pounds of Tobacco.
- Filing and Recording every Declaration, per Side, accounting Fifteen Lines to a Side, and Seven Words to a Line, Nine Pounds of Tobacco.
- A Copy of the same, at the same Rate; not to be charged unless required and delivered.
- Every Appearance entered, Seven Pounds of Tobacco.
- Entry of an Imparlance, Five Pounds of Tobacco.
