

book kept for that purpose; and that he shall be entitled to receive from the sheriff of said county all such monies as may have been collected from him as treble tax, under the act for the better security of the government; and the sheriff is hereby directed and enjoined to repay to him the monies aforesaid, to be reimbursed out of the sums he may have received as collector of the tax, for which reimbursement he shall be allowed in his account with the commissioners of the tax, as directed in other cases mentioned in this act.

An ACT for the payment of the journal of accounts.

**W**HEREAS it appears by the journal of accounts and list of debts, that there is now due from this state the sum of eight thousand four hundred and twenty-six pounds, three shillings and three-pence, current money:

Preamble.

II. Be it enacted, by the General Assembly of Maryland, That the treasurer of the western shore shall and he is hereby authorized and required to deliver out bills of credit which now are or shall be in his hands for the use of this state, to the several persons, their executors, administrators, assigns, or orders, who are allowed on the said journal, or to such of them as shall offer to receive the same, the several sums of money to them respectively allowed, as they appear to be allowed and ascertained by the journal of accounts and list of debts aforesaid.
