CHAP.
XVI.

V. And be it enacted, That the sheriff of Anne-Arundel county shall, without delay, deliver all such public letters and packets as may be delivered him, endorsed as hereafter mentioned, directed to any person or persons residing in Calvert county, to the sheriff of said county or his deputy, and take a receipt for the same; and the sheriff of Calvert county shall, without delay, deliver all such public letters or packets to the person or persons to whom directed, and take a receipt for the same; and the sheriff of Anne-Arundel county shall, without delay, deliver all such public letters or packets delivered him, endorsed as aforesaid, directed to any person or persons residing in Prince-George's, Charles, Saint Mary's, Montgomery, Frederick and Washington counties, to the sheriff of Prince-George's county or his deputy, and take a receipt for the same; and the sheriff of Prince-George's county shall deliver, without delay, all such public letters and packets as may be directed to any person or persons residing in his county, to such person or persons, and take a receipt for the same, and shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in Charles and Saint Mary's counties, to the sheriff of Charles county or his deputy, and take a receipt for the same; and the sheriff of Charles county shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in his county, to such person or persons, and take a receipt for the same, and shall, without delay, deliver all such letters and packets as may be directed to any person or persons in Saint Mary's county, to the sheriff of said county or his deputy, and take a receipt for the same; and the sheriff of Saint Mary's county shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in his county, to such person or persons, and take a receipt for the same; and the sheriff of Prince-George's county shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in Montgomery, Frederick or Washington counties, to the sheriff of Montgomery county or his deputy, and take a receipt for the same; and the sheriff of Montgomery county shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in his county, to such person or persons, and take a receipt for the same, and shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in Frederick or Washington counties, to the sheriff of Frederick county or his deputy, and take a receipt for the same; and the sheriff of Frederick county shall, without delay, deliver all such public letters and packets as may be directed to any person or persons residing in his
