C H A P. CLXIX.

An ACT to establish a board of agriculture for the counties therein mentioned.

Passed both of January, 1808.

WHEREAS societies for the promotion of agricultural and domestic manufactures would, by exciting a spirit of emulation, and by diffusing useful information, tend much to the advancement of the prosperity of the state, and ought to be encouraged; therefore,

Preamble.

II. BE IT ENACTED, by the General Assembly of Maryland, That there be erected, and hereby is erected, a board of agriculture in Cæcil, Kent, St. Mary's, Anne-Arundel, Somerset, Worcester, Baltimore, Talbot, Allegany, Montgomery, Washington and Caroline counties, in the state of Maryland, and that the said boards of agriculture be regulated under the management and direction of the trustees herein after mentioned, to wit:
