THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

Messieurs Quynn and Brice from the house of delegates, deliver to the president a bill, entitled, An act to enable Cassandra Ducker, widow and executrix of John Ducker, late of Anne-Arundel county, deceased, to sell and dispose of certain lands and mills therein mentioned, thus endorsed; "By the house of delegates, November 5, 1778: Read the first time and ordered to lie on the table.

By the HOUSE of DELEGATES, November 11, 1778.

Whereas many of the continental officers, serving in the proportion of this state, have since the rise of articles, been under the necessity of paying more than ten shillings per week allowed by congress for the subsistence of recruits; it is therefore RESOLVED, That the auditor-general allow to such officers, all such sums of money as they actually have expended for the subsistence of such recruits as they raised after the tenth day of December, in the year seventeen hundred and seventy-six, over and above the said ten shillings per week, such actual necessary expence to be evidenced by proper vouchers and proved accounts, or by the certificate of the auditor of the army; provided also it be made appear to the auditor-general of this state, that such officer has used due diligence in forwarding such recruit to some place where they might be furnished with rations.

Which was read and assented to, so endorsed, and sent to the house of delegates by Charles Carroll, Esq; Barrister.
