

VOTES AND PROCEEDINGS, NOVEMBER, 1785. 89

- The Speaker, attended by the members of the house of delegates, appeared in the senate, and the following engrossed bills were presented by the Speaker to his excellency the governor, who signed and sealed the same in the presence of both houses.
- No. 1. An act to approve, confirm and ratify, the compact made by the commissioners appointed by the general assembly of the commonwealth of Virginia, and the commissioners appointed by this state, to regulate and settle the jurisdiction and navigation of Patowmack and Pocomoke rivers, and that part of Chesapeake bay which lieth within the territory of Virginia.
- No. 2. A Supplement to the act, entitled, An act for founding a college on the western shore of this state, and constituting the same, together with Washington college on the eastern shore, into one university, by the name of The University of Maryland.
- No. 4. An act to revive and aid certain proceedings in the general court of the eastern shore.
- No. 5. An additional supplement to the act, entitled, An act for founding a college on the western shore of this state, and constituting the same, together with Washington college on the eastern shore, into one university, by the name of The University of Maryland.
- No. 6. An act to appoint Edward Oldham, and Mary his wife, trustees to take care of the person and property of Joseph Enfor, an idiot.
- No. 7. An act to make valid the election of trustees of the poor of Anne-Arundel county.
- No. 8. An act for altering the time of holding the courts in Queen-Anne's county.
- No. 9. An act to aid conveyances of land improperly enrolled, and for other purposes.
- No. 10. An act to extend the time limited for bringing in and settling claims against this state by the citizens thereof, and for limiting the time for bringing in and settling claims against the said state by citizens of the United States.
- No. 11. An act for the relief of Charles Henry Wharton and Henry Pile.
- No. 12. An act for the relief of sundry persons, securities of Thomas Boyer, late sheriff and collector of Kent county.
- No. 13. An act to confirm the title of a lot of ground in Baltimore-town, in Baltimore county, to James M'Fadon, in fee, for the benefit of the heirs of John M'Fadon, deceased.
- No. 14. An act to grant to Gabriel Peterfon Vanhorn an exclusive right to keep stage-carriages on the public road from the river Susquehanna to the river Patowmack.
- No. 15. An act for the relief of the poor in Talbot county.
- No. 16. A Supplement to the act, entitled, An act empowering the justices of Montgomery county, to assess and levy a sum of money on the inhabitants of said county, for the purposes therein mentioned.
- No. 17. An act for the relief of certain maimed and disabled officers.
- No. 18. An act for extending the causeway through the marsh on the south side of Wiccomico river at the lower ferry, and for other purposes therein mentioned.
- No. 19. An act to establish a road in Somerset county, to lead from the Bear Swamp road till it intersects the road from King's branch to Princess-Anne.
- No. 20. A Supplement to an act, entitled, An act to establish a road in Worcester county from the Sinepuxent road to Walton Purnell and Annanias Hudson's grist-mill, and from thence to Freeman's branch.
- No. 21. An act to authorize the vestry of Stepney parish, in Somerset and Worcester counties, to settle and pay the debts of the parish, and for other purposes.
- No. 22. A Supplement to the act, entitled, An act to appoint a trustee to take care of the person and property of George Shipley, senior, who is insane.
- No. 23. An act to empower Vachel Downes to collect the arrears due for public and county assessments to Samuel Ridgeway, late sheriff and collector of Queen-Anne's county, deceased.
- No. 24. An act to make valid a deed from John Craig to Hugh M'Bride of Caroline county.
- No. 25. An act to make provision for the maintenance and education of Joseph Handy, only son of captain Joseph Handy.
- No. 26. An act to regulate the building and erecting of wharfs in the port of the city of Annapolis.
- No. 27. An act to establish permanent salaries for the chancellor and the judges.
- No. 28. An act to ascertain and establish a permanent salary to the governor.
- No. 29. An act for the more effectual preservation of the breed of wild deer.
- No. 30. An act for the further relief of the securities of Thomas Williams, deceased, late collector of the tax and public dues in Prince-George's county, and for other purposes therein mentioned.
- No. 31. An act relating to the public buildings in Caroline county.
- No. 32. An act to erect a town in Talbot county.
- No. 33. An act for the regulation of the markets in Baltimore-town.
- No. 34. An act relating to replevins.
- No. 35. An act to repeal part of the act concerning marriages.
- No. 36. An act to enable any of the United States to prosecute actions in any court of law or equity against any person residing within this state.
- No. 37. An act to enable John Eagar Howard and George Lux, of Baltimore county, to grant and convey to the commissioners of Baltimore-town, and their successors, a parcel of land adjoining the said town, for the purposes therein mentioned.
