The senate are very desitons of rising on that day, and will do all in their power to effect it; but from the number of bills, (some of them important,) which have come from your house within two or three days past, they have but litte hope, that the business will be finished on the day you propose to adjourn. In addition to these circumstances, the senate would remark, that a committee of conference on the part of both houses is engaged on that most important bill, entitled, "An additional supplement to the act, entitled, An act for regulating the mode of staying executions, and repealing the acts of assembly therein mentioned, and for other purposes," by which it is proposed to give relief to the distresses of the coun. try; and we are satisfied your honourable house would not think of rising until that business is fully and J. The resolution in favour of the examiner-general, was read the second, and by special order the third

The bill to continue in force the acts of assembly which would expire with the present session, was

read the second and third time by special order and will pass

The bill for the punishment of othences committed against banks by the officers thereof, was read the

third time and will pass with the proposed amendments.

Amendments proposed. 1. Strike out the words "officer or director" 1st and 2d lines 1st section and insert "president, directors, cashier, clerk, or other officer." 2. Strike out the first letter "a" 2d line same section, and insert "any." 3. Strike out the word "touching" 3d line same section, and insert the word "of" 4. Strike out the 2d section. 5. Strike out the words "officer or director" 1st line 3d section, and insert the words "president, director, cashier, clerk, or other officer." 6. At the end of the bill add "and not exceeding ten years."

Mr. Gale from the committee submitted the following report:

The committee of conference to whom was referred the bill, entitled, An act for regulating the mode of staying executions and repealing the acts of assembly therein mentioned, and for other purposes report;

That they have taken the same into consideration, and are of opinion that legislative provision should be made, that judgments rendered by a single magistrate should be superseded before two justices of the peace, and not before a justice of the orphans court; but there is considerable difficulty on account of parliamentary usage, in engrating such a provision in the said bill as amended; with a view therefore of making the said provision, it is recommended by the committee of conference, that a new bill should be originated in the senate, which shall contain the above provision. Which was read and concurred in On motion of Mr. Gale, Leave given to bring in a bill, entitled, An act for regulating the mode of

staying executions, and repealing the acts of assembly therein mentioned, and for other purposes. Or. dered, That Messrs. Gale, Maxcy and Emerson, be a committee to prepare and bring in the same.

Mr. Gale from the committee reported the said bill containing the provisions recommended by the committee of conference; which was read the first, and by special order the second and third time, and on motion of Mr Howard, the question was put, Will the senate receive the following as an amendment. Strike out after the words "respectively reside" last line 1st page, the words "or before any justice of the orphans court." Determined in the negative.

On motion of Mr. Gale, the said bill was postponed for further consideration.

The bill respecting certain suits or actions wherein judgments may be reversed and writs of procedendo awarded, was read the third time and will pass.

The bill to repeal so much of the act to regulate lotteries, as provide; for the appointment of lottery commissioners, and their clerk, was read the second time and laid on the table.
