The bill for the benefit of John Jameson of Virginia, and the bill for the revaluation of the real and personal property of St. Mary's county, were read the second, and by special order the third time, passed, and sent to the house of delegates.

The senate adjourns until Monday morning 10 o'clock.

MONDAY, December 11, 1820.

The senate met. Present the same members as on Saturday. The proceedings of Saturday were read. Roger B. Taney, George W. Jackson, Richard W. West, Levin Gale and Richard Carroll, esquires, appeared, qualified and took their seats.

Robert G. Harper, Esq. appeared in the senate.

Mr. Hughlett from the committee reports a bill, entitled, An act for the relief of Sarah Cahall of Caroline county; which was read the first time and laid on the table.

The bill to authorise the erection of a warehouse in the village of Greensborough in Caroline county, was read the second, and by special order the third time, passed, and sent to the house of delegates.

The clerk of the house of delegates delivers the following messages:

BY THE HOUSE OF DELEGATES, Dec. 11, 1820.

Gentlemen of the Senate,

The constitution and form of government having directed that the governor of this state shall be chosen on the second Monday of December in each and every year, and this being the day prescribed, we propose, with the concurrence of your honourable body, to proceed to elect the governor of this state at 12 o'clock to day. Samuel Sprigg and Charles Goldsborough, Esquires, are put in nomination by this house; and we have appointed Messrs. Marriott and William W. Eccleston to join such gentlemen as may be named by you, to count the ballots and report thereon.

Also the bill, entitled, An act to incorporate the trustees of M. Kim's school in the city of Baltimore; the bill entitled, An act to make valid the deed therein mentioned; and the bill, entitled, An act for the revaluation of the real and personal property in Calvert county; which were read the first time and laid on the table.

The bill to settle and ascertain the salary of the members of the council for the ensuing year, was read the second, and by special order the third time, passed, and sent to the house of delegates.

On motion of Mr. West, Leave given to bring in a bill entitled, An act to ascertain the true location of the public roads in Prince-George's county. Ordered, That Messrs. West, Jackson and Carroll, bring in the same.

The bill to incorporate the trustees of M. Kim's school in the city of Baltimore, was read the second and third time by special order, and postponed for further consideration.

The following message was sent to the house of delegates:

BY THE SENATE, Dec. 11, 1820.

Gentlemen of the House of Delegates,

We concur in the proposal contained in your message to go into the election of governor this day at 12 o'clock. No person has been put in nomination by the senate in addition to the gentlemen nominated by your house. We have appointed Messrs. Carmichael and Magruder to join the gentlemen appointed by you to count the ballots, and report thereon.

The senate having previously qualified agreeably to the constitution and form of government, proceeded to the election of a governor. The ballot box being prepared, the ballots were deposited therein, sealed up, and delivered to the committee of the senate appointed to meet the committee of the house of delegates, who retired to the conference room, and after some time returned and reported, that Samuel Sprigg had forty-eight votes, and Charles Goldsborough had forty-six votes. Whereupon it is declared in the senate, that Samuel Sprigg having had a majority of the votes of all the attending members of both branches of the legislature, is duly elected Governor of Maryland.

On motion, Ordered, That Messrs. Gale, Maxcy and West, be a committee of revisal and unfinished business.
